A. Election of Recording Secretary

Chairperson Wendy Krueger opened the floor for nominations. Sue Buckner nominated Marcy Norton. Jerrie Heslov made a motion to close the nominations for Recording Secretary. The motion was seconded by Julia Gandelsman and passed unanimously. Barbara Hamaker made a motion to election Marcy Norton to the office of Recording Secretary, Seconded by Deann Zampelli, the motion passed unanimously.

B. Teen Mentorship Program

Bob Morrisey, representing the new West Hollywood Comprehensive Services Center at Plummer Park, spoke about the youth programs the center will be offering, including a mentorship program. He requested assistance from the Board in helping to locate possible mentors and for WAB members to consider volunteering as well.

C. UN World Conference on Racism, Racial Discrimination; Xenophobia and Related Intolerance

The Board reviewed a draft recommendation to the City Council in support of the UN World Conference on Racism, Racial Discrimination, Xenophobia and Related Intolerance. Jerrie Heslov made a motion that the Board support the recommendation. Seconded by Marcy Norton, the motion passed unanimously.

Sue Buckner made a motion to co-sponsor the LesBios event, seconded by Mina Kedar, the motion passed unanimously.

The Board reviewed a draft recommendation to the City Council in support of "Denim Day". Deann Zampelli made a motion to approve the recommendation, seconded by Rae Mitchell, the motion passed unanimously.
