Madeleine Rackley gave a brief update report on behalf of the Subcommittee. At their next meeting, the Subcommittee will be preparing the outline for the report. Issue areas that will be covered in the report include public safety, city government, census information, and health.

4. Special Event with NOW:

Brief follow up discussion regarding the recent reception hosted with the National Organization for Women at the Sunset Trocadero on November 21st with the President of NOW, Kim Gandy. Approximately \$1500 was raised.

VI. NEW BUSINESS

A. Legislative Issues

The Board discussed the best ways to proceed to address local, statewide and national legislation and policy affecting women. It was suggested that WAB focus on specific issues and prioritize them.

1. Governor's Proposal to eliminate the California Commission on the Status of Women. Brief discussion of the City's resolution in support of the Commission. **No Action Taken.**

B. Congress of Boards and Commissions:

Staff reported on the upcoming meeting of all the City's Boards and Commissions on October 16, 2004. Boardmembers gave input regarding WAB's accomplishments in the past year, for inclusion in a report that will be presented at the event.

C. Healthy West Hollywood Month:

Staff gave a brief overview of the City's programming held during the month of October, promoting wellness in the community.

- 1. Breast Cancer Awareness Month, Kick-off October 4th Rae Mitchell spoke about the activities planned for this year, focusing on outreach and education, which include banners featuring breast cancer survivors and information tables at local markets.
- 2. Domestic Violence Prevention Awards, October 27th WAB members signed up to help host the event.
