Staff reported that an additional banner was being prepared to honor Jodie Curlee, the City's first social services administrator who had recently died.

Kay Buck, Executive Director, Coalition to Abolish Slavery, spoke to the Board about the work of the organization. The Subcommittee scheduled a meeting for March 2nd at 4pm to finish planning the press conference event. Alexander Faynerman from the Russian Advisory Board distributed a resolution that the Board has passed in support of participating in Women's History Month and working with CAST.

A. Legislative Updates:

1. Support for Family PACT:

Deb Farmer provided an update on the Governor's Budget and its impact on Family PACT.

2. Freedom of Choice Act

Review of proposed federal legislation by Senator Barbara Boxer to protect women's reproductive Rights.

3. Healthy Mothers and Healthy Babies Access to Care Act Review of the federal bill blocking injured patients' access to the courts and limiting their compensation. Deb Farmer shared information about conflicting views from amongst women's health providers about the real impact and value of the legislation.

B. City of West Hollywood Kids Fair

The Board briefly discussed sponsoring a booth for this year's event. Staff will forward the exact date of the event to the Board.

C. National Women's Health Month.

The Board discussed ways to participate in National Women's Health Week and National Women's Health Month. Topics discussed included working on Artists for a New South Africa's program to aiding women and children affected by AIDS, information was distributed about the American Cancer Society's campaign about women and heart disease and the Campaign for Microbicides.

D. Amnesty International's Violence Against Women Campaign

Staff suggested inviting a representative from Amnesty International to attend a meeting to discuss their Violence Against Women Campaign and ways the Board can support their efforts.

NOW Campaign Calling for the Firing of University of Colorado Football Coaches:

The Board briefly discussed the campaign by the National Organization of Women calling for the firing of two football coaches form the University of Colorado's football program charged with sexual harassment, rape and cover-ups. It was suggested that comprehensive recommendations related to sexual assault be developed rather than responding to individual incidents.
