A. Cynthia Street / Larrabee Avenue Test Traffic Circle

Staff report from Walter Davis

Commissioner Wayland confirmed the location of the bulb outs.

Commissioner Eichman asked if there were any other traffic circles at off-set intersections in West Hollywood.

Walter Davis replied that this is the first in the city.

Commissioner Wayland asked about crosswalks and stop signs in the traffic circle.

Walter Davis responded that the existing stop signs will be better aligned with the crosswalks..

Commissioner Wayland stated that he is supportive of the device, although he isn't sure it will address the issues at hand.

Commissioner Eichman asked about the size of the traffic circle.

Walter Davis described the size for the preliminary study, explaining that it may change as the study continues.

Commissioner Eichman asked if there would be directional signs.

Walter Davis stated that there would be, as well as arrows on the street.

Commissioner Greene commented that he agrees with Commissioner Wayland, but is cautiously supportive as he also worries about people traveling in the wrong direction. Also, he doesn't see how eastbound traffic will be discouraged. He concluded that he is supportive if the neighborhood wants the device.

Commissioner Schmidt agreed with Commissioner Wayland and offered that another solution would be to make Sunset flow better. He added that he is also concerned with noise issues.

Commissioner Eichman agreed in general, saying that the device does help clarify right-of-way, but he is still concerned about traffic movement going north/south.

Bob Cheung stated that staff could explore expanding the bulb-outs in order to slow traffic and make it a less desirable route.

Walter Davis reminded the commission that modifications may be necessary during the test period.

Commissioner Eichman asked if four months was a long enough test period.

Walter Davis said staff would consider going to six months.

Commissioner Schmidt suggested monitoring traffic on Fridays and Saturdays at 2:00 A.M.

Walter Davis replied that all heavy times are monitored. He added that he is working on loading issues at the hotel nearby.

Bob Cheung said that staff would check with Code Enforcement regarding noise issues.

Commissioner Wayland offered that the Transportation Commission would do more if need be, if there is neighborhood consensus.

Commissioner Greene agreed with Bob Cheung that more could be done during the test phase.

Motion: Approve the installation of a test traffic circle at the Cynthia Street and Larrabee Avenue intersection.

Commissioner Pendleton asked if there were any initiatives to add new charging stations for vehicles.

Bob Cheung replied that the City did have some charging stations, but there was little to no demand for them.

Commissioner Schmidt asked if bikes were allowed to charge at available charging stations.

Commissioner Pendleton stated that it would probably be a different kind of charging station.

Harlan Flagg interjected that it would be easier, now based on a standardization of charging features.

Commissioner Wayland commented that retrofitting should be relatively easy.

Harlan Flagg stated he is willing to help staff with a charging station initiative.

Commissioner Eichman asked for a description of the average electric bicyclist.

Harlan Flagg described them as the general bike-riding public who enjoy having the extra power, especially when going uphill.

Commissioner Eichman asked if pedaling is required.

Harlan Flagg responded that the pedals and throttle work independently.
