I. CALL TO ORDER:

Chair Molly Casey called the meeting to order at 7:26 pm

III. ITEMS FROM THE PUBLIC:

There were no items from the public.

IV. UNFINISHED BUSINESS:

A. West Hollywood Report on the Status of Women

Staff gave a brief recap regarding the work the Board has done so far regarding their review of the West Hollywood Report on the Status of Women. The Board discussed information from recent presentations they received. Some questions arose regarding domestic violence statistics reported by West Hollywood Sherriff's Station and the City and the domestic violence-related services provided by the City's social services providers. The City's Domestic Violence Task Force

representative will be invited back to clarify some information. The Board discussed public safety and, resources for job training Staff distributed an annual report from the City's Housing Division. There will be a presentation at a future WAB meeting regarding the City's housing services.

B. Board Special Televised Meeting on November 10, 2014

The Board discussed whether to utilize the televised meeting to focus on special presentations or hold a meeting focused on their on-going work. The meeting content options were discussed such as including an introduction about what the Board and sharing the Board's Annual Report. It was agreed by consensus that the televised meeting be essentially a regular meeting of the Board in terms of the agenda. Staff will prepare a draft agenda for the Board's review at their October 23rd meeting.

V. LEGISLATION & ADVOCACY DISCUSSION

A. Board Legislative Review Process

The Board continued to discussed ways they could be most effective in making recommendations to the City Council. The Board discussed a draft document outlining a process which has been in development over the past year. The Board agreed by consensus to work as a collective in reviewing legislative issues versus utilizing a subcommittee process. The Board also agreed it would be more efficient for them to collaborate with advocacy organizations and access existing resources for legislative research and analysis versus initiating research from scratch.

VII. NEW BUSINESS

A. Co-sponsorship of Hollywood NOW Annual Meeting

Reina Martinez, President of Hollywood NOW, spoke to The Board about co-sponsoring their annual meeting on November 6, 2014 by providing a meeting location. The meeting will be open to the public and feature guest speaker M. Laura Herrera, VP of Stonewall Young Democrats and President of Planned Parenthood Young Professionals who will be discussing the "Above All Campaign" and reproductive rights. Boardmember Noemi Torres made a motion to support Hollywood Now Annual Meeting which was seconded by Boardmember Nadia Sutton. The motion was approved unanimously.

B. Co-Sponsorship of the International Gaming Association Event on the Harassment of Women in the Public Eye

Boardmember Anne Toole, who is also on the Board of the International Gaming Developers Association, Los Angeles Chapter, discussed tentative plans for an event that feature possibly Sandra Fluke and game industry women. Co-sponsorship from the Board to assist with obtaining a City venue was requested. The Board agreed by consensus to support the event if and when plans are finalized.

C. National Women's History Month 2015

Staff distributed information and gave a brief overview regarding the annual programming for National Women's History Month. It was suggested past/present women leaders who have served on City Council be recognized in some way such as on the Women's History Month banners. It was also suggested that this idea be linked in some way to the Women's Leadership Conference, i.e/ a leadership workshop. Further discussion was tabled.
