The Commission reviewed and considered approval of an Arts Participation Grant in the amount of \$1,000 to the Los Angeles LGBT Center to support the Senior Youth Photo Project.

ACTION: Approve an Arts Participation Grant in the amount of \$1,000 to the Los Angeles LGBT Center to support the Senior Youth Photo Project. **Approved as part of the consent calendar.**

C. Performing Arts and Cultural Affairs Subcommittee Actions Report

The Commission received and filed the Performing Arts and Cultural Affairs Subcommittee's Actions of October 8, 2015, and will consider ratifying recommendations proposed by the Subcommittee:

Approve the award of grant funds totaling \$63,000 to the following City Art Project and Cultural Resource Development Grants: City Art Project Grants – Greenway Arts Alliance; Pen Center USA West (conditioned upon a public presentation of works by WeHo Writing Craft Scholarship recipients); Los Angeles Women's Theatre Festival; Hatchery Arts (dba Hollywood Fringe); Rogue Artists Ensemble; Macha Theatre and Film; and Women in Film (conditioned upon providing a more significant art component in conjunction with its lecture series); and Cultural Resource Development Grants – Classical Theatre Lab, Chad Michael Hall Dance, Inc./Multiplex Dance; IAMA Theatre Company; and Critical Mass Dance Company; and forward recommendation to City Council for approval.

D. Art on the Outside Current, Upcoming and Potential Projects Status Update

The Commission received and filed a status update of Art on the Outside current, upcoming and potential projects.

II. NEW BUSINESS

A. Street Media Needs Assessment Project

The Commission received a presentation from Innovation Analyst Kate Mayerson and Innovation and Strategic Initiatives Manager Francisco Contreras on the Street Media Needs Assessment Project and considered appointing a member of the Arts and Cultural Affairs Commissioner to serve on the Street Media Design Ad Hoc Committee.

Ms. Mayerson spoke on the project and indicated Selbert Perkins Design would conduct a comprehensive study of public assets and wayfinding signage within the city's public right-of-way and open spaces to assist the City with creating a unified pedestrian wayfinding/street media system that uses technology to integrate mapping, signage, and information throughout the City for enhanced urban design, promotion of public transit use and increased revenue generation. She also shared that Council approved the formation of the West Hollywood Street Media Design Ad Hoc Committee to provide guidance in the design development of Citywide Street Furniture, Wayfinding, and Gateway Entry program.

It is anticipated the West Hollywood Street Media Design Ad Hoc Committee would consist of the following:

The ad hoc committee would meet once a month of a period of up to ten (10) months.

ACTION: Appoint Commissioner Beroukhim to serve on the West Hollywood Street Media Design Ad Hoc Committee.

Motion by Commissioner Dishman seconded by Commissioner Rackley and approved.

III. UNFINISHED BUSINESS

A. 2016 Arts Grant Funding Recommendations - One City One Pride

The Commission reviewed scores provided by the peer review panel for One City One Pride Grant applicants and recommended funding allocations based on those scores for approval by City Council

Commissioner Rackley provided an explanation as to why the item was referred to the Arts and Cultural Affair Commission.

Arts Coordinator Michael Che provided an overview of the application and review process and indicated twelve applications were received of which nine (9) arts organizations and individual artists were recommended for funding based on peer review panel scores. He indicated the peer review panel rated applications using the following criteria:

- Excellence and Artistic Quality of Project Proposal (0-35 points)
- Budget and Project Feasibility (0-35 points)
- Ability to illustrate this year's theme "Into The Streets" (0-30 points)

Motioned by Commissioner Rackley, seconded by Commissioner Beroukhim and approved.

B. Art on the Outside Subcommittee Report

The Commission received a report from the Art on the Outside Subcommittee on its meeting held October 22, 2015 and considered ratifying recommendations proposed by the Subcommittee.

Commissioner Dishman reported that the Subcommittee:

- Declined extending the Alex Israel vertical billboard art exhibition on the Sunset Strip
 noting direction to staff to work with LA><Art to deinstall the art, if the art is no longer
 representative of the artist due to environmental deterioration.
- Discussed temporary art/sculpture project proposals by Jeremy Thomas ("Old Route 66") and by Yi Hwan Kwon. It was the consensus of the Subcommittee to refer this item back to staff noting that the more abstract figurative artwork proposed by Kwon exhibited recently. The Subcommittee expressed interest in viewing a sample of Kwon's proposed art work in bronze and understanding how the artist plans to add color to the bronze. The Subcommittee requested that staff follow up on additional questions regarding engineering specifications and maintenance of the work.
- Reviewed temporary art/sculpture project, "The Chase," (4 sculptures) by Gerardo Hacer and recommended the Arts and Cultural Affairs Commission approve the project for installation on the Santa Monica Boulevard/Doheny median from June 2016 through the end of 2017, at a budget not to exceed \$20,000 and authorize staff to communicate its interest in color differentiations for the coyote and rabbit sculptures.
- Recommend the Arts and Cultural Affairs Commission approve the Temporary Art/Sculpture Project Proposal, "The Chase" (4 sculptures) by Gerardo Hacer, for installation on the Santa Monica Boulevard/Doheny median from June 2016 through the end of 2017and authorize staff to communicate its interest in a secondary color to distinguish the coyote and rabbit works.

ACTION: Approval of the temporary art/sculpture project, "The Chase" (4 sculptures) by Gerardo Hacer for installation on the Santa Monica Boulevard/Doheny median from June 2016 through the end of 2017, at a budget not to exceed \$20,000, and authorize staff to communicate its interest in a secondary color to distinguish the coyote and rabbit works.

Moved by Commissioner Beroukhim, seconded by Commissioner Lee approved.

C. Urban Art Subcommittee Report

The Commission received a report from the Urban Art Subcommittee on its meeting held October 15, 2015 and considered ratifying recommendations proposed by the Subcommittee.

Commissioner Beroukhim reported the Subcommittee received a presentation from Art Consultant Jody Rassell and artist team MERGE Conceptual Design (Franka Dienhelt

and Claudia Reisenburger) on the concept plan for the urban art project at 9001 Santa Monica Boulevard.

The project calls for the construction of a new mixed use building of 37 units and 69,833 sq. ft., with decks 8453 sq. ft. and commercial space of 9587 sq. ft. with underground parking of 52,268 sq. ft.

The public art component focuses on the main entrance of the building consisting of a large two-story public space at the ground level, as well as a two-story open space at the upper level. The art concept consists of selected lyrics from songs that are connected to the West Hollywood music industry and inscribed on sculptural elements. By combining the lyrics in a cloud-like installation, highlighting and fading them individually in a specific sequence, a new poem emerges that tells the story of how music was shaped and how it helped shape the City and its inhabitants.

The percent for budget is approximately \$154,679.19

ACTION: Approve Stage II Schematic Plan by MERGE Conceptual Design (Franka Dienhelt and Claudia Reisenburger) for the urban art project at 9001 Santa Monica Boulevard.

Motioned by Commissioner Lee, seconded by Commissioner Carvalheiro and approved noting the no vote of Commissioner Dishman.
