# WEST HOLLYWOOD DISABILITIES ADVISORY BOARD MINUTES APRIL 27, 2011

#### 1. CALL TO ORDER

Chairperson Anna Swett called the meeting to order at 6:03 p.m.

#### 6. PUBLIC COMMENT

Vikee Waltrip of West Hollywood spoke about the benefits for the deaf community of the video relay phone system over the TTY line that City Hall uses. She asked that the new West Hollywood Library include services for the deaf community.

Mark Helmuth of West Hollywood spoke about ensuring that the new West Hollywood Library include services for the deaf community, including new sign language books and a video relay phone. He also noted that there aren't many resources for the deaf community at City Hall.

Timothy Silver of West Hollywood spoke about the need for earthquake preparedness for the deaf community.

## A. EVALUATION OF CITY-SUBSIDIZED TRANSPORTATION PROGRAMS – Phase One Recommendations

The Board received a project update from Jesse Slansky of the West Hollywood Community Housing Corporation about Hayworth House (1234 Hayworth Avenue) and a presentation about a new project at 1145-1151 N. La Brea Avenue with 32 units. The proposed project on La Brea will include 15 units for people living with special needs, including three units for transition-age youth between the ages of 18 and 25 who have aged-out of the foster care system.

He asked that the meeting be adjourned in honor of his father, James Nollie Watts, Sr., who turned 92 on March 23<sup>rd</sup> and who organized funds to establish Cibola General Hospital in Grants, New Mexico, 50 years ago.
