SUBJECT: The City Council will consider directing staff to continue to research placing an initiative to increase the City sales tax rate on a future ballot and authorizing staff to issue a request for proposals for consulting services related to the research, analysis, and strategy for a potential initiative.

5.B. WERLE BUILDING PROJECT (626 ROBERTSON BOULEVARD) [O. DELGADO, S. CAMPBELL, H. COLLINS]:

SUBJECT: The City Council will consider: increasing the project's scope and budget; initiating the construction drawing phase; approving Amendment 1 to the Agreement with the IDS-Group for Architectural and Design Services; authorizing staff to negotiate short-term lease agreements pursuant to the relocation of programs; and, approve Amendment 1 to the Agreement with Rosa Lowinger and Associates, the City's Civic Art Preservation and Maintenance Contractor, for assistance with the Werle Building Project's Mitigation Plan.

Approve increasing the Werle Building RECOMMENDATIONS: 1) Project budget by \$1,239,000 from \$950,000 to \$2,189,000; 2) Authorize the Department of Public Works to proceed with Construction Drawings for the Werle Building Improvement Project C.I.P. 55-2015/16-02 and issue bid documents for construction upon the completion of the Construction Drawings; 3) Approve Amendment 1 to the Agreement for Services with IDS-Group for Architectural Design Services for the Werle Building Project, and increase the not-to-exceed amount of the Agreement by \$57,000 for a total not-to-exceed amount of \$145,000; 4) Authorize the Facilities and Field Services Manager to negotiate and execute one or more change orders to the Agreement with IDS-Group for additional but unforeseen work, which may develop during the project; the total value of which shall not exceed 10% (\$14,500) of total contract amount. 5) Approve Amendment 1 to the Agreement for Services with Rosa Lowinger and Associates for relocation, storage and return of the June Mazer Lesbian Archives as part of the Werle Building Project Tenant Mitigation Plan, increase the not-to exceed amount of the Agreement by \$70,000 for a not to exceed amount of \$145,000, and extend the term of the Agreement by 12 months; 6) Authorize the City Manager, or designee, to negotiate short-term lease agreement(s) pursuant to the relocation of the West Hollywood Recovery Center, June Mazer Lesbian Archives, and One Gallery; 7) Authorize the City Manager, or designee, to execute documents incident to the Agreement(s); and 8) Authorize the Director of Finance and Technology Services to allocate \$1,239,000 in 2016 Lease Revenue Bond Proceeds to the appropriate project accounts in the Debt Funded Capital Projects Fund for the Werle Building Project.

5.C. PARKING RATES AND HOURS OF OPERATION FOR THE CITY HALL AUTOMATED GARAGE LOCATED AT 8300 SANTA MONICA BOULEVARD/1085 SWEETZER AVENUE [O. DELGADO, J. ROCCO]:

SUBJECT: The City Council will consider adopting a resolution establishing the hours of operation and public parking rates for the automated garage behind City Hall located at 8300 Santa Monica Boulevard, approval of a purchase order with Sentry Control Systems to

upgrade the revenue control equipment network infrastructure with software to accept new "Chip and Pin" smart credit card processing, and approval of an amendment to the agreement with ABM Onsite Services-West Inc. to add the new parking structure located at 8300 Santa Monica Boulevard/1085 Sweetzer Avenue.

RECOMMENDATIONS: 1) Adopt Resolution No. 15-RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD ESTABLISHING THE HOURS OF OPERATION AND PARKING RATES FOR THE CITY HALL AUTOMATED GARAGE LOCATED AT 8300 SANTA MONICA BOULEVARD/1085 SWEETZER AVENUE"; 2) Adopt Resolution No 15-_ _, "A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD AMENDING THE MASTER FEE RESOLUTION (RESOLUTION NO. 15-4701) BY ADDING MUNICIPAL PARKING STRUCTURE AND SUPERSEDING LOCATION FOR MUNICIPAL PARKING LOT #4 TO THE SCHEDULE OF FEES AND CHARGES FOR THE PARKING DIVISION"; 3) Approve an amendment to the contract with ABM Onsite Services-West, Inc. to increase the "not to exceed" amount for FY15-16 by \$312,649, for FY16-17 by \$418,521 and FY17-18 by \$418,521 for a total additional amount of \$1,149,691, for all three fiscal years to add the operation of the automated parking structure located at 8300 Santa Monica Boulevard/1085 Sweetzer Avenue: 4) Approve an amendment to the contract with Sentry Control Systems to increase the "not to exceed" amount of \$200,00 by an additional \$42,523.00 for a total of \$242,523.00 to upgrade the network infrastructure software for the revenue control equipment installed at the City's parking structures to accept new "Chip and Pin" smart credit card processing and fraud-protection standards; and 5) Authorize the City Manager or designee to execute documents incident to the agreements.

5.D. AMEND POLICY REGARDING SUNSET STRIP STREET LIGHT POLE BANNER SPONSORSHIP [P. AREVALO, M. LOUIE, L. MINNICH]:

SUBJECT: The City Council will consider amending the existing Sunset Strip Street Light Pole Banner Policy to withdraw authority of the Sunset Strip Business Association (SSBA) to manage the street light pole banners along Sunset Boulevard and retain revenue generated from banner sponsorships, effective 90 days from approval of the new policy. RECOMMENDATIONS: 1) Amend the existing Sunset Strip Street Light Pole Banner Policy as follows: a) Withdraw authority of the SSBA to manage the street light pole banners along the Sunset Strip and retain revenue generated from banner sponsorships; b) Transfer the authority to manage the street light pole banners along the Sunset Strip and collect revenue from the street light pole banner sponsorships along the Sunset Strip to the City of West Hollywood; and c) Direct future revenue generated from the street light pole banner sponsorships on the Sunset Strip to supplement the Sunset Strip Business Improvement District (District) budget and review the amount of supplemental funding annually as part of the District renewal process; 2) Make the new policy

(Attachment A) effective 90 days from its approval by City Council; 3) Authorize the City Manager or his designee to notify the SSBA of the amended policy and effective date; and 4) Authorize the City Manager or his designee to contact the existing Sunset Strip Street Light Pole Banner Program sponsor (Brown-Forman Corporation) to negotiate a new sponsor agreement for the Sunset Strip street light pole banners with the City and return to Council with an update and recommendations.

5.E. PURSUE CicLAvia OPEN STREETS EVENT IN WEST HOLLYWOOD [L. HORVATH, B. SIEGL, C. CORRAO]:

SUBJECT: The City Council will consider co-hosting a future CicLAvia open streets event in West Hollywood, and directing staff to pursue grant funding for the event through Metro's Open Streets Program.

RECOMMENDATIONS: 1) Direct staff to work with organizers of CicLAvia to develop plans to co-host a future event with the City of Los Angeles; and 2) Direct staff to apply for open streets funding through Metro to fund a potential event.

5.F. ADVISORY BOARD APPOINTMENT [Y. QUARKER, M. CROWDER]:

SUBJECT: The City Council will consider making an at-large appointment to the Russian Advisory Board.

6.A. AMENDMENT TO THE CITY OF WEST HOLLYWOOD NOISE CONTROL ORDINANCE [O. DELGADO, J. AUBEL]:

SUBJECT: The City Council will consider amending Section 9.08.050 and Section 9.08.060 of the West Hollywood Municipal Code.

RECOMMENDATION: Introduce on first reading Ordinance No. 15-___, "AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF WEST HOLLYWOOD AMENDING TITLE 9 OF THE WEST HOLLYWOOD MUNICIPAL CODE, SECTIONS 9.08.050 and 9.08.060 (NOISE CONTROL ORDINANCE)".

6.B. AN ORDINANCE OF THE CITY OF WEST HOLLYWOOD ADDING A NEW CHAPTER 9.30 TO THE WEST HOLLYWOOD MUNICIPAL CODE TO REGULATE DRONES, UNMANNED AIRCRAFT AND MODEL AIRCRAFT [L. MEISTER, M. JENKINS, P. AREVALO]:

SUBJECT: The City Council will consider adopting an Ordinance to regulate Drones, Unmanned Aircraft and Model Aircraft in the City of West Hollywood.

RECOMMENDATION: It is recommended that the City Council introduce , "AN ORDINANCE on first reading the attached Ordinance No. 15-OF THE CITY OF WEST HOLLYWOOD ADDING A NEW CHAPTER 9.30 TO THE WEST HOLLYWOOD MUNICIPAL CODE TO REGULATE DRONES, UNMANNED AIRCRAFT AND MODEL AIRCRAFT" regulating drones consistent with the permissible scope of authority discussed below, to protect the safety and welfare of residents. The ordinance would do the following: Require registration and a permit for operation of any unmanned aircraft in the City; Prohibit unmanned aircraft (hobby/recreational and commercial) from interfering with manned aircraft, operating at night, operating within 25 feet of persons not involved in operation, operating inconsistent with state or federal flight rules, capturing visual images or audio recordings of persons without consent when a reasonable expectation of privacy exists, flying 350 feet or less above a public or private school during school hours without permission, capturing visual images of public or private school grounds during school hours without permission, flying within the airspace above City parks, City Hall and sheriff and fire stations, and interfering with firefighting, police, or emergency response activity; Prohibit unmanned hobby/recreational model aircraft from operation beyond the operator's visual line of sight or higher than 400 feet above ground, as FAA rules do not apply such limitations to commercial UAS operations; Provide exemptions for government-operated UAS and hobby/recreational or commercial unmanned aircraft that has received permission from the FAA to operate beyond the limitations of the ordinance; and Make violation of the ordinance a misdemeanor.
