CITY OF WEST HOLLYWOOD WOMEN'S ADVISORY BOARD MEETING MINUTES

I. CALL TO ORDER:

Chair Salguero called the meeting to order at 7:08 pm.

A. Roll Call

II. APPROVAL OF THE MINUTES:

Boardmember Eyres made a motion to approve the minutes from the meeting of October 21, 2015 and Vice Chair Torres seconded the motion. The motion was approved unanimously.

III. ITEMS FROM THE PUBLIC:

Barbara Meltzer, Vice-Chair, Human Services Commission for the City of West Hollywood, spoke about the issue of aging in place/aging in community, the City's five-vear strategic plan, and its effects on women.

IV. SPECIAL PRESENTATION: AGING IN PLACE/AGING IN COMMUNITY FIVE-YEAR STRATEGIC PLAN:

Elizabeth Savage, Director, Department of Human Services and Rent Stabilization presented to the Board the City's five-year strategic plan for Aging in Place/Aging in Community. She requested that Boardmembers continue to review the report and the strategies and send any questions they might have to her via email by November 30, 2015.

The Board discussed the Aging in Place/Aging in Community Five-Year Strategic Plan. The Board discussed the plan's current \$4.3 million dollar budget; whether or not the City's affordable housing stock will continue to grow as new residential construction is built and whether or not senior housing will be a priority as the cost of living continues to rise; and whether or not social and community programming will grow for women since they outnumber men 2 to 1 in the report.

V. WEST HOLLYWOOD REPORT ON THE STATUS OF WOMEN:

The Board reviewed potential additions to the West Hollywood Report on the Status of Women. Staff was directed to cluster economic related information for the Board's further review. Staff presented a potential proposed process for gathering input from City Advisory Boards regarding their respective constituency for inclusion in the update to the West Hollywood Report on the Status of Women.

VI. LEGISLATION & ADVOCACY DISCUSSION:

Staff gave a brief update regarding recent legal challenges to the Reproductive Fact Act and the campaign recently launched in support of the Each Woman Act and that staff will distribute information to the Board about ways to get involved.

VII. UNFINISHED BUSINESS:

A. Televised Board Meeting, October 21, 2015

The Board suggested working to make sure more people attend their next televised meeting but agreed by consensus that it was a successful meeting.

National Women's History Month 2016

The Board reviewed their current subcommittee assignments for National Women's History Month 2016.

- Vice Chair Torres presented updates to the Board regarding the Women's Art Exhibition event.
- Boardmember Eyres presented updates to the Board regarding the Women and Books Club that meets monthly at the West Hollywood Library. The March book is *The Art of Memoir* by Mary Karr. Notes from the Subcommittee were distributed.
- Boardmember Eyres presented updates regarding the International Women's
 Day event and that she attended the most recent planning meeting. She stated
 that the meeting organizer needs help in promotion of the event to women,
 identifying or booking vendors for the event, booking and coordinating a fashion
 show or other activities during the event.
- Boardmember D'Amico presented updates to the Board regarding the Women and the Graphic Novel event and suggested potential speakers to invite to speak at the event.
- Boardmember Eyres reported the that Hollywood NOW will present an event for Board co-sponsorship at the December 10, 2015 meeting.

Staff presented updates to the Board regarding the Women Manifest kickoff event on Friday, March 4, 2015 and potential ways that the Board could be involved at the event; how the Board can support the other various Women Manifest events throughout the month of March such as a film and dance event; and encouraged the Board to attend the next Women Manifest mixer at Gracias Madre on December 11, 2015 at 6:00 pm.

Staff reported that the process for the selection of the Women's History Month banner nominees could be the same as last year if the Board desired and that

members would nominate individuals via an online form. Staff would report back at the next meeting on the nominees and the Board will officially select the two women who will be honored with banners for Women's History Month at the December 10th, 2015 meeting.

Vice Chair Torres made a motion to approve the minutes of January 15, 2015 and Boardmember Casey seconded the motion. The motion was approved unanimously.
