ii. "Contessa" by artist Stuart Kusher

The Subcommittee will review and discuss the temporary art/sculpture project "Contessa," a mirror bronze sculpture by artist Stuart Kusher proposed for the Santa Monica Boulevard/Doheny median in accordance with the temporary art proposal review criteria with a proposed exhibition from February 1, 2016 – February 1, 2017.

The Subcommittee will review and discuss the temporary art/sculpture project "How to Look at Sculpture" by artist David Schafer proposed for West Hollywood Park or Plummer Park in accordance with the temporary art proposal review criteria with funding not to exceed \$6,480 and a proposed exhibition from June - December 2016.
