I. CALL TO ORDER: The Sunset Strip BID Advisory Board meeting was called to order by Chair Lee Maen at 10:35 a.m.

C. Public Comment

MARK MONTGOMERY, SUNSET PLAZA, spoke regarding comments made by staff at the December 9, 2015 meeting (Item VII – Items from Staff) concerning the November 4, 2015 letter to City Council regarding traffic impacts on the Sunset Strip. He indicated traffic impacts mentioned in the letter were indeed part of the LaCienega project and the matter was not resolved satisfactory.

As a result of Mr. Montgomery comments, Chair Maen requested that staff agendize "Sunset Strip Traffic Control Presentation" for a future meeting.

IV. NEW BUSINESS

A. Presentation Regarding Homeless Outreach Services

The Board received a presentation from the City of West Hollywood's Social Services Division team in partnership with representatives from PATH (People Assisting the Homeless), Block by Block, and the West Hollywood Sheriff's Department.

Social Services Supervisor Corri Planck and Social Services Program Administrator Leslie Isenberg spoke regarding the City's homeless outreach services and its partnership with PATH, AIDS Project Los Angeles, the Los Angeles LGBT Center as well as the greater Los Angeles Homeless Collaborative and its partnership with National Council of Jewish Women Fund and Jewish Vocational Services.

PATH representatives Associate Director, Hollywood Region, Karen Barnes; PATH Director of Metro LA Programs Tescia Uribe and PATH's West

Hollywood Outreach Team La Toi Pledger spoke briefly regarding its day-today, in the field outreach homelessness efforts and its relationship with the West Hollywood Sheriff's Department in addition to its engagement with the homeless with respect to transportation to shelters, food and medical services.

Ms. Planck distributed "Our Response to Homelessness" pocket brochure that includes a snap shot of services for adult and youth; year round emergency shelters; food; medical; 12-step recovery and Sheriff contact information. She indicated that Sunset Strip Businesses can contact the Social Services Division, PATH or the West Hollywood Sheriff's Department with any questions.

VII. ITEMS FROM BOARD MEMBERS

A. Street Media Adhoc Committee

Board Member Browning reported on the January 5, 2016 Street Media Ad Hoc Design Committee. At the meeting, the committee received a presentation from Sylbert Perkins who presented three unique concepts for way-finding and West Hollywood gateways. Based on initial design concepts each district/area would have a defined identity. She indicated the committee will meet the 1st Tuesday of each month and requested that staff forward the presentation to the Board.

B. Sponsorship Adhoc Committee

Chair Maen and Vice Chair Latteri reported they met to discuss BID sponsorships and determined it would be in the best interest of the Board to focus its attention on the Sunset Strip Street Pole Banners.

Vice Chair Latteri spoke regarding the NFL's return to Los Angeles for the 2016 season as a potential marketing opportunity and benefit for the Sunset Strip.

Board member Relecker spoke regarding Employer Support of the Guard and Reserve and asked the Board to consider receiving a presentation from the organization that promotes cooperation and understanding between Reserve Component Service members and their civilian employers and to assist in the resolution of conflicts arising from an employee's military commitment.

VIII. ITEMS FROM THE STAFF

A. Sunset Strip Street Pole Banner Staff Report

Economic Development Analyst Laura Minnich indicated that Jack Daniels has expressed interest in continuing banner sponsorship along the Sunset Strip.

B. Gridlock Officers on Sunset

Economic Development Analyst Laura Minnich indicated Mr. Montgomery's letter to City Council was included in the December 9, 2015 meeting agenda packet and that staff will seek additional information concerning Sunset Strip gridlock as part of the Sunset Strip Traffic Controls presentation for the February 10, 2016 meeting.

C. City LineX

Staff announced the upcoming launch of City LineX on January 19, 2016 at 5 p.m. City LineX is a free shuttle service that will operate peak hours from West Hollywood to Hollywood and Highland.

Chair Main commented on certain transportation gaps in the City and questioned the feasibility of a trolley service along the Strip.

Sunset Strip Business Improvement District Security Ambassador's Report - January 2016

• 18 Total Calls for Service

- Six total calls in regards to homeless individuals disrupting business operations. Two were being loud and talking to themselves and four were panhandling. All individuals were offered PATH and resource information.
- Two calls were received for requests for safety escorts. One was provided for business employees to their cars and another was provided for an intoxicated female to reunite with her friends.
- Three calls from businesses requesting assistance with intoxicated individuals. Two individuals were yelling at staff and patrons. Both complied with Security Ambassador's request to calm down and move along. One individual had fallen on the ground and Security Ambassadors relocated his friends who took him home.
- There were three requests from businesses to assist with crowd control and traffic control. In one incident the Security Ambassadors arrived on scene and observed two individuals shoving each other. The individuals were immediately separated before the incident escalated.
- The Security Ambassadors responded to four calls in regards to complaints and/or disturbances. Two were from residents reporting loud noises in their neighborhoods, one was reports of a fight in progress and the other was a disruptive customer yelling obscenities at restaurant staff. All incidents were resolved peacefully.

• 139 Total Ambassador Services

- The Security Ambassadors provided safety escorts for ten individuals this month. One was an intoxicated female who was stumbling down the street with her skirt hiked up above her waist and exposing her buttocks. She was covered up and reunited with her friends who drove her home. Another female was observed sitting on the curb as two males were trying to coerce her into their car. The males quickly drove off as the Security Ambassadors arrived on scene. She was from out of the country and she spoke very little English, but we assisted her in finding her cousin at a nearby club. All others were females by themselves, slightly inebriated and lost.
- There were a total of five fights in which the Security Ambassadors intervened this month. All involved individuals declined needing any medical attention or police assistance. There were two additional verbal confrontations in which the Security Ambassadors were able to separate those involved prior to them becoming physical.
- The Security Ambassadors contacted six individuals throughout the month, who were observed drinking alcohol
 in public. All individuals were compliant, emptied their containers and left the area with no further issues.
- While on routine patrol, the Security Ambassadors located a man lying on the ground vomiting. The man was unable to stand and was vomiting. Paramedics were called and he was transported to the hospital.
