#### I. CALL TO ORDER:

Chair Salguero called the meeting to order at 6:11 pm

#### II. APROVAL OF THE MINUTES:

Boardmember Eyres made a motion to approve the minutes from the meeting of December 10, 2015 and Boardmember Moore seconded the motion. The motion was approved unanimously with Boardmember Toole abstaining.

#### III. ITEMS FROM THE PUBLIC:

Michelle Dennis, Treasurer, Women's League of Voters – Los Angeles, spoke about the League of Women Voters' Transgender and Gender Expansive Voter Registration and Voter Empowerment event in March 2016 and invited the Board to attend the event and that she'd provide more information to the Board in the future.

James Wen, Transgender Advisory Board Chair, spoke about the League of Women Voters' Transgender and Gender Expansive Voter Registration and Voter Empowerment Event and requested the Board co-sponsor the event; provide assistance in helping with staffing the event, and general promotion.

Michael Wojtkielewicz, Disabilities Advisory Boardmember, spoke about mental health and the role it plays in women's lives and general statistics regarding mental health awareness.

Christina Banchero, spoke on behalf of Women Manifest and the upcoming events that would be taking place during Women's History Month throughout the City of West Hollywood and greater Los Angeles in the month of March.

Chair Salguero spoke about the event being a success and that there is a number of legislation that is currently out there or being introduced that will make it easier or harder for women to obtain safe and affordable reproductive healthcare. Chair Salguero also mentioned that parental notification will most likely be on the 2016 California ballot.
