ARTS AND CULTURAL AFFAIRS COMMISSION MEETING MINUTES

I. CALL TO ORDER

The meeting was called to order at 5:03 p.m. by Commission Chair Todd Williamson

C. Approval of the Agenda:

Motion by Commissioner Carvalheiro seconded by Commissioner Rackley and approved.

D. Approval of the Oecember 17, 2015 meeting minutes.

Motion by Commissioner Dishman, seconded by Commissioner Carvalheiro and approved noting one minor correction to the minutes.

E. Introductions:

The Commission received an introduction to Mr. Tai Sunnanon, Founder and Director of For the Social Good and Ms. Felicia Rosenfeld, Executive Director of the Dance Resource Center.

Mr. Sunnanon spoke concerning the mission of For the Social Good and indicated the organization provides affordable work-space and resources to nonprofits and small businesses to launch and grow their organization or business in partnership with the government and private sector. The organization launched December 1, 2015 and has eleven (11) members.

Ms. Rosenfeld spoke regarding the mission of Dance Resource Center which functions as a service organization to provide the Los Angeles area dance community access to information, resources and services; and promotes the visibility and viability of greater Los Angeles dance on local, state and national levels. The

organization has approximately 200 members. However the organization has outreach to nearly 3,000 people.

F. Public Comment

James Wen, member of Transgender Chorus of Los Angeles, thanked the Commission for supporting Transgender Chorus of Los Angeles through the City Arts Project Grant, as the funded grant project for the Gay Men's Chorus of Los Angeles.

B. Performing Arts and Cultural Affairs Subcommittee Actions Report

The Commission reviewed, received and filed Performing Arts and Cultural Affairs Subcommittee Actions Report of January 14, 2016 and considered ratifying recommendations proposed by the Subcommittee.

III. NEW BUSINESS

A. Community Enrichment Grant – American Russian Business Council

The Commission, at the request of the Performing Arts and Cultural Affairs Subcommittee, reviewed and considered approval of a Community Enrichment Grant to the American Russian Business Council in the amount of \$1,000 to support arts programing in conjunction with International Women's Day to be held March 8, 2016 at Plummer Park in Fiesta Hall.

The 2016 International Women's Day event, "Pledge for Parity," will feature guest speakers who will speak on the progress of gender parity nationally and internationally while encouraging the community to move from talk to purposeful action by requesting individuals to pledge to help women and girls achieve their ambitions; challenge conscious and unconscious bias; call for gender-balanced leadership; value women and men's contributions equally and create inclusive, flexible cultures. The event will also feature musicians and dancers who will entertain while helping to create a balanced and meaningful program.

ACTION: Approval of a Community Enrichment Grant in the amount of \$1,000 to the American Russian Business to support arts programing in conjunction with International Women's Day to be held March 8, 2016 at Plummer Park Fiesta Hall. **Motion by Commissioner Dishman, seconded by Commissioner Beroukhim and approved.**

IV. UNFINISHED BUSINESS

A. Art on the Outside Subcommittee Report

The Commission received a report from the Art on the Outside Subcommittee on its meeting held January 28, 2016 and considered ratifying recommendations proposed by the Subcommittee.

Commissioner Dishman reported the Subcommittee:

- 1. Reviewed and recommended approval of the temporary mural by artsit Cleon Peterson titled 214 Lafayette Project at Kung Pao Bistro as art and not creative signage in accordance with the temporary art proposal review creiteria.
- 2. Reviewed five (5) temporary art project proposal received between July 2015 and December 2015 of which the Subcommittee expressed interest in the following proposal as potential Art on the Outside projects:
 - a. "The Cube" a temporary time-based art project by artist Manuel Lima: The Subcommittee requested that staff obtain more logistical information from the artist in addition to exploring potential liability, public safety and building and safety issues. The Subcommittee also requested that staff

invite the artist to present at the February 25, 2016 meeting.

- 3. Received a presentation from staff on a potential exhibition for the Santa Monica Boulevard median at Holloway Drive. As a result, it was the consensus of the Subcommittee as well as direction to seek illuminated sculptures for this site.
- 4. Reviewed and considered recommending approval of the temporary art/sculpture project "Dream Portal" by artist Colleen M. Kelly. It was the consensus of the Subcommittee as well as direction to staff to refer this item to the full commission for its review.
- 5. Recommended that the Arts and Cultural Affairs Commission approve two additional proposals including "Burnt Forest: Drawing the Line" by artist Doron Gazit and "Food-Prints" by artist Brett Snyder, Edward Morris and Sussanah Sayler and funding not to exceed \$24,000 as part of 2016-2017 fiscal year project budget.

ACTION: Approve two additional proposals including "Burnt Forest: Drawing the Line" by artist Doron Gazit and "Food-Prints" by artist Brett Snyder, Edward Morris and Sussanah Sayler and funding not to exceed \$24,000 as part of 2016-2017 fiscal year project budget as recommended by the Art on the Outside Subcommittee.

Motion by Commissioner Beroukhim, seconded by Commissioner Rackley and approved.

B. West Hollywood Mural Program

The Commission reviewed and provided feedback to staff on the West Hollywood Mural Program final documents.

ACTION: Approval of the West Hollywood Mural Program and Final documents. Motion by Commissioner Dishman, seconded by Commissioner Beroukhim and approved noting direction to staff to provide a layout of what murals will go where for the mural program at West Hollywood Park, and that staff research language applicable to murals on private property and include that language in the guidelines, as appropriate.

C. Urban Art Subcommittee Report

The Commission received a report from the Urban Art Subcommittee on its meeting held January 21, 2016 and considered ratifying recommendations proposed by the Subcommittee.

Commissioner Beroukhim reported that the Subcommittee:

 Received a presentation on the final comprehensive art plan for the urban art project at 1250 Fairfax and recommended approval of Stage III Final Art Plan by artist Cliff Garten (Cliff Garten Studio) in accordance with the City's Urban Art Policy and Guidelines. Received a presentation from art consultant Corinne Weitzman and artist Heath Satow on Stage II Schematic Design for the Urban Art project at 8017-8029 Norton Street in accordance with the City's Urban Art Policy and Guidelines. It was the consensus of the Subcommittee that the team explore the green space to the right of the entry stair; explore a less formal and contemporary concept/approach and submit a more developed/definitive schematic design of what the art will look like in addition to providing concepts the art integrated into the building design.

ACTION: Approve Stage III Final Art Plan by artist Cliff Garten (Cliff Garten Studio) for the urban art project at 1250 Fairfax Avenue as recommended by the Urban Art Subcommittee.

Motioned by Commissioner Dishman, seconded by Commissioner Beroukhim and approved.

D. 2016-2018 Arts and Cultural Affairs Commission Work Plan

The Commission received an update from staff on the Commission's 2016-2018 Work Plan.

Arts Administrator Andrew Campbell provided a preliminary draft of the Commission's 2016-2018 Work Plan and indicated each of the Commission's subcommittees would have an opportunity to review and provide input before approval of the plan by the full Commission.

E. West Hollywood Cultural/Creative Plan

The Commission received a report from the Performing Arts and Cultural Affairs Subcommittee, art consultant Amanda Carlson and staff on the development of a cultural/creative plan for the City of West Hollywood.

Commission Rackley, Arts Consultant Amanda Carlson and Arts Administrator Andrew Campbell spoke respectively on the significance of the cultural/creative plan and the multi-approach to developing the plan and deliverables as well as how commissioners might contribute to the process. Strategies included:

- Embedding an artist into the process to enhance community engagement.
- White Papers (reports on the state of the arts and cultural affairs programming).
- Litmus test for success and what will make for a successful process.
- Project title.

Commissioners suggested that the process should:

- Direct conversation about physical space.
- Help create a strong visual identity that incorporates technology and contributes to the visual/cultural achievements of the City.
- Answer questions about West Hollywood's arts identity.
- Seek input from persons outside city boundaries.
- Seek input from artists, architects and other arts professionals.

Next steps include:

- One-on-one conversations with City Staff who have led community engagement processes.
- One-on-one conversations with ACAC commissioners and City Councilmembers.
- Present preliminary timeline, based on conversations with Arts and Culture Division staff to PACA.

Commissioner Lee and Rackley expressed interest in hosting a "living room session" to engage members of the public around West Hollywood's Cultural/Creative Plan.
