# WEST HOLLYWOOD HUMAN SERVICES COMMISSION MINUTES – FEBRUARY 13, 2007 COMMUNITY CONFERENCE ROOM, CITY HALL

#### I. CALL TO ORDER

## II. INSTALLATION OF COMMISSIONER

The oath of office was administered to Hywel W. Sims, who was declared installed as a new commissioner. Councilmember John Duran and former Commissioner Peter Mackler spoke about Commissioner Sims, and the entire Commission and staff welcomed him.

Minutes of the January 11, 2007, meeting were approved by consensus, with Commissioner Augeri noting that he should be listed on the hunger subcommittee along with Commissioner Henry.

# V. <u>UNFINISHED BUSINESS</u>

## A. YEAR-END REPORT ON SOCIAL SERVICES PROGRAMS

Daphne Dennis presented the year-end report on social services programs, noting changes in status such as the removal from probation of Dispute Resolution Services, due to improvements in performance, as well as some programmatic changes, such as the HIV program at the Gay & Lesbian Center.

Commissioner Farmer said she was glad to see that the reports contained more than numbers, and that stories about the impact of the programs were present.

Staff assignments regarding current agencies were reviewed. David Giugni is working with legal, food, nutrition, and mental health agencies, and APLA. Craig Rhea is working with Aid for AIDS, AIDS Healthcare Foundation, Being Alive, Partners, WHEST, GLC Health, WeHo Life, PAWS, Russian Community Center, and Van Ness Recovery House. Leslie Isenberg is working with JFS, PATH, Women Helping Women, and programs for children and families.

## VI. NEW BUSINESS

## A. SENIOR SAVINGS PROGRAM

Craig Rhea reported on the senior savings program sponsored by the City, and said that a final version of the materials should be available later this month. There was discussion of how businesses were contacted, and whether a Russian version of the materials will be available. Commissioner Davis asked for Out of the Closet to be included in the program.

#### B. SUPPLEMENTAL NUTRITION INITIATIVE

David Giugni reported on the Supplemental Nutrition Initiative that has been developed as part of the "End Hunger in West Hollywood" program. The initiative includes distribution of emergency food packets.

# VII. ITEMS FROM THE COMMISSION

Commissioners Augeri and Cislowski attended the Snow Day in the park. Commissioner Augeri also reported the presence of 32 shopping carts in front of 959 Palm.

Commissioner Davis said his neighborhood, on Hayworth, is witnessing lots of dog waste on the streets. He also reported on the chairs meeting, including items from the public safety and transportation commissions.

Commissioner Farmer spoke about the safety of the crosswalk at Koo Koo Roo, where pedestrians are not sufficiently visible to traffic.

The annual Valentine's Dance will be held tomorrow, with the assistance of the Social Services Division.
