WEST HOLLYWOOD HUMAN SERVICES COMMISSION MINUTES - FEBRUARY 10, 1998 COMMUNITY CONFERENCE ROOM, CITY HALL

I. <u>CALL TO ORDER</u>

A. CALL TO ORDER

The West Hollywood Human Services Commission was called to order by Chairperson Steven Davis at 6:00 p.m., Tuesday, February 10, 1998, in the Community Conference Room at City Hall, 8300 Santa Monica Boulevard, West Hollywood.

A quorum was present at all times. Staff present included Lloyd R. Long, Director of Human Services; Daphne Dennis, Social Services Administrator; Tom West, Social Services Program Specialist; and Jeff Book.

C. POSTING OF AGENDA

The Secretary reported that notices for the meeting had been posted as required.

D. PROCEDURE FOR PUBLIC COMMENT

Persons desiring to address the meeting were asked to complete a request form.

II. MINUTES

The minutes of the meetings of January 13, 1998, were approved on a motion by Commissioner Rosenfeld, seconded by Commissioner Graney.

Minutes of the special meeting of February 7, 1998, were not yet available.

III. <u>UNFINISHED BUSINESS</u>

A. <u>UPDATE FROM WEST HOLLYWOOD CARES</u>

Thomas Dyer introduced his new co-worker, Paul Joseph, and distributed to Commissioners a report outlining demographics and methodology for the DSSN

program. He reported that their survey of members showed 81 percent crediting the program with helping them to maintain safer sexual behavior. By proclamation of the Mayor, the week of Feb. 14-21 will be "DSSN Week" in West Hollywood, featuring a reception at Mickey's, 6 to 10 p.m. on Thursday, Feb. 19, to which Commissioners will be invited. Thomas also reported that they have commissioned artist John Planas to help design their next media campaign.

IV. NEW BUSINESS

A. <u>SOCIAL SERVICES CONTRACT SAVINGS</u>

Daphne Dennis reported that \$11,235 in savings are available for reprogramming at this time. Various possible uses for the money were discussed, including the West Hollywood Senior Center, Van Ness Recovery House, the Sheriff's Activity League, PAWS, JFS Nutrition's home-delivered meals program, Project Angel Food, after-school tutoring programs, and one-time capital expenditures.

Joan Lindell, director of the Senior Center, discussed their desire to increase the hours of their security guard from 25 per week to full-time.

Commissioners discussed the pros-and-cons of the options, including whether there may be alternate ways of meeting some of the concerns, and, pending the Needs Assessment Report, what seems to be the most pressing need of the community.

Commissioner Graney moved that the \$11,235 be used to expand the contract with Van Ness Recovery House to provide for an additional full-time counselor in their outpatient treatment program, which focuses on substance abuse, particularly of crystal methamphetamine.

The motion was seconded by Commissioner Rosenfeld, and unanimously approved.

Lloyd Long will discuss the Senior Center security question with the City Manager, to see if there are other ways to respond.

B. PROPOSED TIMELINE FOR NEEDS ASSESSMENT REVIEW AND SOCIAL SERVICES CONTRACTING

Daphne Dennis presented the draft timeline for the needs assessment review and social services contracting process, opening with submission of the RFP to the Commission on March 10 and to the Council on March 16; distribution of information on the RFP orientation meeting on April 1; submission of the needs assessment report to the Commission on April 14-16, and to the Council on

April 20; orientation meeting and public release of the RFP on April 22; deadline of May 29 for responses; staff analysis of responses durign June; and submission of funding recommendations to the Commission in July, and to the Council not later than August 3. Negotiations of specific contract terms would follow upon Council approval of the contract concepts.

This report was received and filed.
