C. Performing Arts and Cultural Affairs Subcommittee Actions Report

The Commission received and filed the Performing Arts and Cultural Affairs Subcommittee's Actions of February 11, 2016 and March 10, 2016, and considered ratifying recommendations proposed by the Subcommittee:

K. Commercial Business Mural Application – 8500 Santa Monica Boulevard

The Commission reviewed a Commercial Business Mural Application submitted by Al & Ed's Auto Sound at 8500 Santa Monica Boulevard and considered approval of the mural, "Freddy Mercury," by artist Milena Ilina (Blikeme).

Commissioner comments focused on the overall scope, intent and content of The Plan including language, typography and imagery.

ACTIONS:

By consensus, the Commission recommended that the Plan:

- include an executive summary for each "white paper;"
- not contain language that is overly academic, text heavy or repetitive;
- utilize typography and imagery as a tool to make the Plan more user-friendly;
- format as a brochure rather than a textbook or formal report.

It was also the consensus of the Commission that the Performing Arts and Cultural Affairs Subcommittee review specific documents related to the Cultural Plan, provide recommendations and report back to the Commission for its approval.

The Commission received a report from staff on an art opportunity at 8120 Santa Monica Boulevard.

Public Art Coordinator Rebecca Ehemann spoke briefly concerning the process by which to realize an exhibit at the south west corner of Santa Monica Boulevard and Crescent Heights. She indicated that the City via its Department of Public Works has expressed considerable interest in placing at this location. The Commission would need to identify the art opportunity/theme, budget and process.

Potential opportunities/themes included:

- Temporary art exhibited on a plinth
- A permanent urban artwork
- Art & Landscape
- Art & Environment
- Painted Mural

mural, "David Bowie," by artist Milena Ilina (Blikeme) as art and not creative signage.

ACTION: Approve the mural, "David Bowie," by artist Milena Ilina (Blikeme) as art and not creative signage for installation at 7750 Santa Monica Boulevard. **Approved as part of the Consent Calendar.**

II. UNFINISHED BUSINESS

A. City Hall Parking Structure – Murals in the Parking Bays

The Commission received presentations from artists Bron, Kim West, Chase and MONCHO1929 and considered approving the mural concept proposals for the City Hall Parking Structure parking bays.

ACTION: Approve the artists' mural concept proposals for the City Hall Parking Structure parking bays including "Business Park" by artist Bron; "Untitled" by artist Kim West; "We Are All One" by artist Chase; and "Flight Plan" by artist MONCHO1929.

Motion by Commissioner Beroukhim, seconded by Commissioner Lee and approved.

B. West Hollywood Cultural Plan

The Commission received a report from the Performing Arts and Cultural Affairs Subcommittee (PACA), art consultant Amanda Carlson, and staff on the development of *WeHo Arts: The Plan*, a cultural plan for the City of West Hollywood and authorized the PACA Subcommittee to approve specific documents related to The Plan to be submitted to City Council.

Ms. Carlson spoke concerning the planning process that would include a series of "white papers" on Cultural Facilities and Creative Space (May); Arts Business Partnerships (June); Arts and Cultural Affairs Public Programming (July); Public Art (September); One City One Pride (October); and Aging in Place Initiative (November 2016). She indicated the Plan is intended to celebrate West Hollywood's diverse cultural identity, commemorate its achievements in the arts to date, articulate a shared vision for the future, and secure the artistic, cultural and creative legacy of West Hollywood.

Ms. Carlson also spoke concerning community input and participation that would include involvement with the social practice artist; arts and culture pop-ups; online engagement; commissioner office hours; living room sessions; arts posse/volunteer corps; and small group meeting with stakeholders.

Staff anticipates that the art would be installed for a period of three to five years and that funding would come from the Department of Public Works.

ACTION: By consensus, the Commission recommended "Art and Environment" as the theme of the exhibit.

B. Temporary Art Project Proposal – Community Arts Resources (CARS) This item was referred to the Art on the Outside Subcommittee.
