**CALL TO ORDER:** Mayor Horvath called the meeting to order at 6:47 p.m.

**PLEDGE OF ALLEGIANCE**: Ivy Bottini led the Pledge of Allegiance.

### REPORT OF CLOSED SESSION AGENDA:

City Attorney Jenkins reported that the Closed Session was called to order at 6:00 p.m. He stated that there was no public comment. He stated that one item was added to the Closed Session Agenda; which was a matter of threatened litigation that came to the City's attention today. He reported that Council agreed to participate in a Friend of the Court Brief (Amicus Brief) in a case titled, State of West Virginia, et al vs US EPA. He further stated that the purpose of the Amicus Brief is to support the EPA's clean power plan. He reported that the closed session adjourned at 6:30 p.m. with no additional reportable action.

City Attorney Jenkins also provided clarification on Councilmember D'Amico's request to have an Item on this Agenda regarding the Settlement in the Owens v City of West Hollywood case. He clarified that the Item was not placed on the Agenda, because the Item is not ready to be heard due to additional information and issued raised since the last meeting. He stated that the Item will be agendized for a future meeting.

City Attorney Jenkins also reported that after the last City Council meeting he felt uncomfortable with the way he interrupted Ivy Bottini during the discussion of the West Hollywood Park Item. He stated that he called Ms. Bottini and expressed his regret that he did not make it clear why her remarks, though important, were best made during the appropriate time during the meeting. He explained that the record of the meeting is organized by topic and that we have to adhere to certain procedures; however he also stated that he was sorry to have interrupted her and that they cleared the air during their conversation.

TOM DEMILLE, WEST HOLLYWOOD, expressed concern with the use of profanity during public comments. He also commented on the upcoming Presidential election.

AMANDA GOODWIN, WEST HOLLYWOOD, spoke regarding vehicle and pedestrian traffic issues surrounding Shake Shack.

MICHAEL TUIACH, LOS ANGELES, spoke as Area Director of Shake Shack, thanking Council for support of the new business, and stated that they are working on mitigation measure for the auto and pedestrian traffic.

TINA BANCHERO, LOS ANGELES, spoke regarding Women Manifest, and thanked Council for support. She also expressed concern with issues surrounding some of the exhibit pieces, and asked the City to clarify their policy in the future.

CHELSEA BYERS, LOS ANGELES, spoke regarding Women Manifest and the issues surrounding the City's policy on censorship.

The following individuals did not wish to speak, but submitted citizen position slips in support of various Consent Items: Karen O'Keefe (2.L.), Tai Sunnanon (2.S.)

### COUNCILMEMBER COMMENTS AND MEETING ATTENDANCE REPORTS:

Councilmember Heilman wished the Iranian Community a Happy Nowruz and also wished everyone a Happy Easter. He commented on Item 2.P. and stated that there is literature available in the foyer regarding the number of children in Foster Care in need of homes. He spoke regarding the change in policy regarding LGBT couples fostering and adopting children. He asked the Parking Manager to speak with Ms. Goodman regarding the City's efforts as it relates to parking near Shake Shack.

Mayor Pro Tempore Meister reported that she attended the recent Westside Cities Council of Governments (WSCCOG) meeting, where the Board voted to issue a letter of opposition to AB45 which would make changes to how the state and local government deals with household hazardous waste and would impose another unfunded State mandate on municipalities. She also reported that the Board was asked to participate in advocacy efforts with the Cities of Santa Monica and West Hollywood to amend the State Ellis Act. She also reported on her attendance at the recent Westside Urban Forum, where they discussed a neighborhood integrity initiative proposed for 2017 for the City of LA. She spoke in support of Item 2.N. and thanked her colleagues for their support of Item 2.S. She also thanked former Councilmember Abbe Land for putting AB 1561 on Council's radar.

Councilmember D'Amico addressed the concerns raised regarding traffic surrounding Shake Shack. He registered is abstention of Item 2.V. and thanked Mayor Pro Tempore Meister for sponsoring Item 2.S.

Councilmember Duran reported on his recent attendance at the American Political Public Affairs Committee (AIPAC) Conference in Washington D.C., where he was a speaker. He spoke regarding Item 2.J. and thanked City staff and HACoLA for providing housing for over 23 chronically homeless individuals in West Hollywood. He also expressed his concerns and apologies to the Artist and Women's Manifest and stated that the City does not tolerate any sort of censorship.

Mayor Horvath congratulated the new Mayor of Beverly Hillis, John Mirisch, and Vice-Mayor Nancy Krasne after their recent Installation. She also congratulated former Councilmember Abbe Land, who was recognized as Woman of the Year by Congressman Adam Schiff. She reported that she received a letter from Elton John AIDS Foundation, stating that the Oscar party raised \$6.2M. She spoke regarding Item 2.H., and thanked her colleagues for their support, City Staff and the Transgender Advisory Board. She spoke regarding the success of the Iranian LGBT community event. She thanked Women's Manifest for their exhibit, and stated that she found Brooke Mason's work empowering and apologizes for any offense to the artist. She asked Staff to work towards clarifying the City's processes and making sure we are

consistent in the guidelines we create. She invited everyone to the upcoming Women Leadership Award event and the wrap party on March 31<sup>st</sup>. She congratulated Style Fashion Week. She also reported that she attended a reception to greet the President Mau of Taiwan. She spoke regarding the upcoming Metro Board Meeting this Thursday. She reported on the upcoming dance showcase at Fiesta Hall as part of the Women's Manifest programming. She also spoke regarding the upcoming *Coffee with Captain* event coming up to welcome our new Sherriff's Captain to the community. Mayor Horvath expressed concern over the Trump campaign, and stated that she will be sending a letter to L.A. County Mayors to join her in denouncing his rhetoric and informing him that his hatred has no place in Los Angeles County. She also congratulated Project Angel Food; who reported that they delivered their 10,000,000 meal.

### **CITY MANAGER'S REPORT:**

City Manager Arevalo apologizes for the challenges in the neighborhood surrounding Shake Shack, and stated that the City is working with the business to mitigate these traffic issues. He also commented on the issues surrounding the Women's Manifest Art Exhibit, and apologized to artist and curator for the miscommunication.

### 4. UNFINISHED BUSINESS:

### 4.A. PUBLIC SAFETY UPDATE [K. COOK, H. PEREZ, A. WILLIAMS, D. MICK, D. GIUGNI]:

SUBJECT: The City Council will receive an update on public safety activities, and provide additional direction to staff.

Director of Public Safety Kristin Cook provided background information as outlined in the staff report dated March 21, 2016.

Mayor Pro Tempore Meister requested clarification on Appendix 1A and asked whether robberies should be included as crimes against persons. Captain Perez clarified that since it is property being taken, it is not considered a crime against a person. An assault is a crime against a person. Meister requested clarification on whether the current mail thefts were included in the report, and the Captain clarified that these were listed under Residential Burglary or Grand Theft. Mayor Pro Tempore Meister requested that the Sheriff's Department start tracking Part II Crimes, at least to show if there are any changes each year.

TAI SUNNANON, WEST HOLLYWOOD, spoke regarding surviving a hate crime in Washington DC in October 2010.

KAYE MCKLAINE, WEST HOLLYWOOD, spoke regarding Councilmember D'Amico's comments during the last City Council meeting.

NIR ZILBERMAN, WEST HOLLYWOOD, spoke regarding dangers of crystal meth in this city.

Councilmember D'Amico thanked Lt. Aloma for his outstanding job as Acting Captain. He spoke regarding the recent reallocation of funds and stated that this was a new way of thinking has a great effect on public safety and a reduction in crime. He requested clarification on the high number of assaults listed for the Westside of the City, and asked that the department focus on determining why.

Councilmember Heilman thanked Staff for the report. He spoke regarding window being smashed at high-end stores and asked if there could be extra patrols in the area and requested that an effort be made to track

these types of crimes. He also expressed concern with the number of assaults on the Westside and requested that in the future, the reports could show whether these types of assaults are associated with a particular alcohol serving establishments. He requested that the Fire Department partner with Social Services to determine if those that come in to get their blood pressure checked need additional assistance and resources. He also requested that Council needs to take another look at the current Neighborhood Watch program to establish standards and revitalize this program.

Mayor Pro Tempore Meister requested clarification from Code Compliance regarding construction noise complaints and if they involved non-permitted construction. Code Compliance Supervisor Dan Mick clarified that the complaints were regarding extended hours and just construction noise in general.

She spoke regarding the Sheriff's Department organizational study and stated that there is more to be done based on the recommendations from Council. She offered to meet with the Captain to discuss further and work together on the study.

Councilmember Duran stated that the Sheriff's Department has done great work to help users of crystal meth, and partnering with City on recovery efforts.

Mayor Horvath thanked the Sheriff's Department and Staff for their hard work. She spoke regarding the improved communications and noted an improvement in overall public safety. She spoke regarding an upcoming Satisfaction Survey meeting scheduled for Saturday, April 16, 2016 at 9:30 a.m. Mayor Horvath spoke regarding ensuring that we are making efforts to address various issues, including assaults, and overserving.

**ACTIONS**: 1) Receive an update on and provide direction to staff regarding public safety priorities including crime prevention, customer service, enforcement, deployment, neighborhood livability, nuisance issues, and public education; 2) Receive an update on and provide direction to staff regarding the organization study conducted of West Hollywood Sheriff's Station by staff and the Contract Law Enforcement Unit; 3) Receive an update on and provide direction to staff regarding the Sheriff's Department and mental health resources; 4) Receive an update on and provide direction to staff regarding improving Sheriff's communication; and 5) Receive an update on and provide direction to staff regarding the Advanced License Plate Recognition (ALPR) program and a surveillance camera program. **Approved by Consensus.** 

## 4.B. WEST HOLLYWOOD MINIMUM WAGE POLICY [P. AREVALO, M. LOUIE, J. JIMENEZ]:

SUBJECT: The City Council will consider and provide direction on whether to establish a citywide minimum wage policy.

LOS ANGELES MAYOR ERIC GARCETTI, LOS ANGELES, spoke in support of minimum wage increase, and spoke of other cities supporting the increase as well.

Arts and Economic Development Manager Maribel Louie and Assistant to the City Manager Janet Jimenez, provided background information as outlined in the staff report dated March 21, 2016.

BRETT LATTERI, WEST HOLLYWOOD, is owner of The Den on Sunset and spoke regarding implications of increase on hospitality business, and requests further study on increase.

AMANDA HYDE, WEST HOLLYWOOD, spoke regarding experiences as a female worker in her career and as a small business owner, and fully supports the increase.

RACHEL TORRES, LOS ANGELES, spoke in support of the increase, and shared statistics on economic growth in hospitality in many cities in our region.

GENEVIEVE MERRILL, WEST HOLLYWOOD, spoke in opposition of the increase.

DON ZUIDEMA, WEST HOLLYWOOD, spoke in support of employees and raising the standard of living, but this particular increase is not the correct way to go about it.

TED GREEN, WEST HOLLYWOOD, spoke in opposition and asks to wait after the statewide vote.

DAVID DICKERSON, WEST HOLLYWOOD, spoke in support of increase, but concerned with timeline.

PHILIP CUMMINS, WEST HOLLYWOOD, spoke in opposition of the timeline of the increase.

MYLENA CHRISTINA, WEST HOLLYWOOD, spoke in opposition to the increase as a small businesses owner.

SANDRA FLUKE, WEST HOLLYWOOD, spoke in support of an increase.

CATHY YOUNGBLOOD, LOS ANGELES, spoke in support of an increase.

ALEXANDRA WEYMAN, LOS ANGELES, works for an organization that represents 20,000 hotel employees, and supports increase, but discussed the difference with tipped workers.

JEREMY BLASI, LOS ANGELES, spoke regarding tipped workers as well.

OWEN WARD, LOS ANGELES, spoke regarding his concerns about this particular plan, not that he is opposed to the increase.

AARON PEARL, LONG BEACH, expressed concern with some of the items in the staff report and possible loopholes.

GABRIELLA ROSCO, LOS ANGELES, spoke in support of an increase.

YOLA DORE, WEST HOLLYWOOD, spoke regarding those that may lose their federally funded assistance due to an increase in pay.

DAVID FANAROT, LOS ANGELES, spoke in favor of a slow timeline.

DANIEL COLLINS, WEST HOLLYWOOD, spoke in support of an increase.

JAMES DUKE MASON, WEST HOLLYWOOD, spoke regarding saving small businesses, but ultimately supports increase.

MARK SAFFIAN, WEST HOLLYWOOD, spoke in support of an increase.

DUSTAN BAHON, WEST HOLLYWOOD, spoke in support of an increase.

RABBI JONATHAN KLEIN, LOS ANGELES, spoke in support of an increase.

KAREN O'KEEFE, WEST HOLLYWOOD, spoke in support of an increase.

SHEAR AVORY, LOS ANGELES, spoke in support of an increase.

ALEXANDRA NAGY, WEST HOLLYWOOD, spoke in support of an increase.

WALKER FOLEY, WEST HOLLYWOOD, spoke in support of an increase.

WALTER SCHILD, LOS ANGELES, is a restaurant owner and spoke about working together to get wages to cooks and dishwashers in the kitchen.

AUSTIN CYR, LOS ANGELES, spoke in favor of increase and how it's good for businesses.

BRUCE CAMPBELL, LOS ANGELES, spoke in support of an increase. .

BEN COLEMAN, WEST HOLLYWOOD, spoke about a more practical implementation of the wage increase.

COREY CLEMENS, WEST HOLLYWOOD, spoke about increase affecting supply chain as a whole in the green industries.

WESLEY BRIDLE, WEST HOLLYWOOD, spoke in support of an increase.

ESTEVAN MONTEMAYOR, WEST HOLLYWOOD, spoke regarding his family and his support for the increase.

JOE GUARDARRAMA, WEST HOLLYWOOD, spoke in favor of the minimum wage.

GENISE SCHNITMAN, SANTA MONICA, read a letter from Santa Monica Councilmember Kevin McKeown, in support of the item.

CAROL KRAVETZ, WEST HOLLYWOOD, spoke in support of an increase.

STEVE MARTIN, WEST HOLLYWOOD, spoke in opposition to the item.

VICTOR OMELCZENKO, WEST HOLLYWOOD, spoke in opposition by highlighting smaller Russian businesses east of Fairfax.

DIANE CROWTHER, WEST HOLLYWOOD, spoke as a small business owner east of Fairfax, and asked Council to take their time on this decision.

LARRY BLOCK, WEST HOLLYWOOD, spoke in opposition to the item and the need to study how it will affect those on fixed incomes.

BEA FONSECA, HOLLYWOOD, spoke in support of an increase.

The following individuals did not wish to speak, but submitted citizen position slips in support of the proposed Item: Ed Buck, Estevan Montemayor, Michael Wojtkielewicz, Heidi Shink, Wesley Bridle, Jason Soudah, Amarra Mchale, Michael Dolan, Jay Fuentes, and Stacey Jones.

Mayor Pro Tempore Meister requested clarification on what City would be

comparable with West Hollywood as it relates to studying this issue. Maribel Louie responded that Santa Monica would be the comparable City. Mayor Pro Tempore Meister also asked if there was any outreach to the Russian business community, and Staff stated that Outreach had not been conducted as of yet, as it is one of the recommendations in staff report, but stated that the West Hollywood Chamber of Commerce has had meetings with the business community. Staff also confirmed that over 70% of businesses in West Hollywood have 25 or fewer employees.

Councilmember Heilman thanked staff and UCLA for the research conducted and expressed appreciation for businesses coming to speak out. He stated that many of the West Hollywood businesses are already paying their workers over \$15/hr., and stated that we would not be one of the last cities in Los Angeles County to move forward on this issue. He spoke regarding this conversation beginning in September 2014 with updates brought to council in 2015 and stated that this is something that Council has been working on for quite some time. He spoke in support of the Item and spoke in support of reviewing the increase in 2018, just as the City of Pasadena is doing. He spoke in support of incorporating a small business incentive package as well. He expressed concern with how to handle the issue of tipped employees vs. back of the house employees gaining the increase.

Councilmember Duran spoke about the theme of progressiveness in all of the public comments and stated that West Hollywood residents and workers are already earning 35% more than those in the City of LA. He expressed concerns regarding the fate of small businesses and the ability for the City to maintain its unique identity. He stated that if the Item passes, he would like to see a delayed implementation and an exemption for businesses with 15 employees or less.

Councilmember D'Amico expressed his appreciation for everyone who came out to speak on this issue. He spoke regarding not wanting to compare West Hollywood with Los Angeles and that a 20% increase in wages will cause a 20% increase in cost for 25% of our residents; who are on fixed incomes. He also expressed concern with giving raises to tipped employees. He spoke in support of waiting until after the November election to see where this issue is headed.

Mayor Pro Tempore Meister thanked everyone who came out to speak. She stated that there needs to be outreach to the businesses in the Russian-speaking community. She agreed that the issue of how this will affect tipped employees needs further research and discussion. She stated that our City cannot be compared to other cities; especially Los Angeles. She spoke in support of an increase but in favor of moving forward with a starting point of \$12/hr. and then reviewing the impacts and also seeing what recommendations come from the County's small

business initiative in May and the ballot measure in November.

Mayor Horvath thanks everyone who came to speak, also. She agreed that West Hollywood is not like most cities and stated that we should look at the Santa Monica model on this issue. She spoke in support of the City's entire business community, but stated that income inequality is a pressing issue, and that's why municipalities are taking up the conversation. She spoke in support of increasing the minimum wage and stated that this is just one step toward a concerted effort to create affordability.

**ACTIONS**: 1) Receive the report providing an overview of wages paid by West Hollywood businesses; 2) Direct City Attorney to prepare an ordinance establishing a City of West Hollywood minimum wage within 60 days and requiring the payment of a city-wide minimum wage as follows: i. July 1, 2017 the hourly wage shall be \$12.00, ii. July 1, 2018, the hourly wage shall be \$13.25, iii. July 1, 2019, the hourly wage shall be \$14.25, iv. July 1, 2020, the hourly wage shall be \$15.00; 3) Allow an additional year for implementation for business with 25 employees or less; 4) Raise the minimum wage each year after 2021 according to the CPI; 5) Create incentives for small business; 6) Include the Learner's Exemption; 7) Direct staff to conduct outreach meetings with the business community to present the framework of the ordinance and solicit their input prior to returning to Council with the draft ordinance; and 8) Direct staff to return in 2018 with future modifications as appropriate, including those reflecting the impacts of the 2016 Election and potential future changes in regional and state policies. Motion by Mayor Horvath, seconded by Councilmember Heilman.

Councilmember D'Amico made a Substitute Motion to: 1) Receive the report providing an overview of wages paid by West Hollywood businesses: 2) Direct City Attorney to prepare an ordinance establishing a City of West Hollywood minimum wage within 60 days and requiring the payment of a city-wide minimum wage of \$12.00/hr. as of July 1, 2017 for business with 26 or more employees; and require the payment of a citywide minimum wage of 12.00/hour as of July 1, 2018 for businesses with 25 or less employees and non-profits of any size; 3) Include a Learner's Exemption; 4) Direct staff to conduct outreach meetings during a 60-day discussion period with the business community, included small businesses, to present the framework of the ordinance and solicit their input and study the issue of workers between the ages of 16-17 who have a work-permits, as well as tipped workers, prior to returning to Council with the draft ordinance; 5) Follow-up on the Los Angeles County small business initiative and the result of the 2016 Election. Councilmember Duran seconded the Substitute motion and it passed with Councilmember Heilman and Mayor Horvath voting No.

City Council agreed by Consensus to Table Items 4.E. and 5.B. to the April 4, 2016 meeting.

4.C. UPDATED ALTERNATE MODE COMMUTE INCENTIVE PROGRAM FOR CITY EMPLOYEES [S. DEWOLFE, J. KEHO, B. SIEGL, C. SCHROEDER, S. SCHUMACHER, D. WILSON, L. QUIJANO]:

SUBJECT: The City Council will consider making permanent the incentives in the Pilot Alternate Mode Incentive Program to encourage employees to utilize alternate modes of transportation and reduce single-occupant vehicle commute trips in West Hollywood.

ACTIONS: This Item was moved to the Consent Calendar.

4.D. AMENDMENT TO THE AGREEMENT FOR SERVICES WITH DAKOTA COMMUNICATIONS FOR OUTREACH SERVICES FOR METRO & RAIL TRANSIT AFFAIRS [C. SCHROEDER, H. MOLINA, S. DEWOLFE, J. KEHO, J. HANKAMER]:

SUBJECT: The City Council will consider amending the agreement for services with Dakota Communications, with sub-consultant The Robert Group, to modify the scope of work and increase the not-to-exceed amount of the agreement for outreach services for Metro and rail transit affairs.

VICTOR OMELCZENKO, WEST HOLLYWOOD, spoke in opposition to the Item and stated that the City is low on totem pole for an extension.

The following individuals did not wish to speak, but submitted citizen position slips in opposition to the proposed Item: Michael Dolan and Jesus Fuentes.

Mayor Pro Tempore Meister expressed concern that the consultant had not yet reached out to or received commitments of support from certain LA City Councilmembers, developer Rick Caruso, who has proposed a large luxury building on San Vicente, the Beverly Center, Los Angeles and West Hollywood Associations and various other stakeholder groups.

Councilmember Duran stated that he and Councilmember Heilman are on the Metro Subcommittee and he stated that although outreach to the community groups is needed, the focus at this point has been trying to reach and meet with those that are making the decision regarding a possible extension.

Councilmember Heilman stated that he supports this Item and there is a strategy that has been developed to try to get transit in West Hollywood.

Councilmember D'Amico thanked Staff for their hard work on this, but stated that he cannot support spending anymore funds on this Item. He stated that he would rather Council influence the decision makers by making those calls directly to them to determine whether they will support our efforts.

**ACTIONS**: 1) Approve Amendment No. 1 to the Agreement for Services with Dakota Communications to expand the scope of services and increase the amount of the agreement by \$200,000 for a total not-to-exceed amount of \$400,000; 2) Authorize the City Manager or designee to execute documents incident to the agreement; and 3) Authorize the Director of Finance and Technology Services to allocate \$200,000 from unallocated General Fund Reserves to account number 100-3-07-07-531019 to fund the cost of the amendment. **Motion by Councilmember Duran**, **seconded by Councilmember D'Amico**, and approved with **Councilmember D'Amico** and **Mayor Pro Tempore Meister voting NO**.

**ACTIONS**: City Council made the following appointments for Mayor and Mayor Pro Tempore, to be installed on April 18, 2016 at the Reorganization Meeting beginning at 6:00 p.m.: Lauren Meister - Mayor; John Heilman - Mayor Pro Tempore.

### 5.B. SUPPORTING SMALL BUSINESS IN WEST HOLLYWOOD'S NEW URBANISM [L. MEISTER, J. D'AMICO, A. LOVANO]:

SUBJECT: The City Council will consider an initiative directing staff to research policies and planning tools that will help attract independent, small businesses to West Hollywood and keep our existing small business community intact by making operating small business in our City more economically feasible.

**ACTIONS**: This Item was Tabled.

### 5.C. CO-SPONSORSHIP OF LA PRIDE CHRISTOPHER STREET WEST'S

## 46TH ANNUAL TRANSGENDER, LESBIAN, GAY, BISEXUAL PRIDE FESTIVAL AND PARADE IN WEST HOLLYWOOD [E. SAVAGE, C. SMITH]:

SUBJECT: City Council will consider requests related to the 2016 LA Pride Festival and Parade. Christopher Street West (CSW) will be presenting requests related to their 2016 event plan and programming including new requests such as additional street closures and facility uses as well as increased sponsorship. The event is scheduled for Friday, June 10th, Saturday, June 11th and Sunday, June 12th, 2016.

Director of Human Services and Rent Stabilization Elizabeth Savage and Special Events Manager Cleo Smith provided background information as outlined in the staff report dated March 21, 2016.

CHRISTOPHER CLASSEN, EVENT PRODUCER, spoke regarding details of the event and the six (6) additional requests presented to Council in a supplemental report.

Councilmember Duran spoke regarding the noise impacts and spoke in support of closing portions of Robertson and in support of a mailer that included musical performance information.

Councilmember D'Amico stated that he supports the Item and is in favor of a 1:00 a.m. closure with one stage open to reduce noise.

Councilmember Heilman asked if during the event debrief this year that Staff and CSW look into a multi-year contract. He spoke in support of the additional requests, but expressed concern with impacts on small businesses if Robertson is closed.

City Manager Arevalo spoke regarding issues with closures on Robertson, and also stated that adding additional hours would incur additional Public Safety costs of approximately \$25-30K; which could be brought back for Council approval.

Mayor Pro Tempore Meister stated that she's fine with the extended hours as long as music is lowered for the last hour. She spoke in support of a reduced ticket price of \$10 for Friday event, more outreach to businesses on Robertson, and a more detailed mailer. She spoke in opposition to broadcasting the event.

Mayor Horvath spoke in support of extended hours, Friday night programming, the use of the 5-story parking structure, a more detailed mailer, debriefing schedule and all of Staff's recommendations.

**ACTIONS**: 1) Affirm the City's commitment to allow CSW to use City property and facilities through the 2018 LA Pride Festival and Parade and
