# SUNSET STRIP BUSINESS IMPROVEMENT DISTRICT ADVISORY BOARD MEETING MINUTES MONDAY MAY 2, 2016

#### A. Sunset Strip BID Budget Fiscal Year 2017

The Board received an update from staff on the revised proposed Sunset Strip Business Improvement District Budget for Fiscal Year 2017.

Arts and Economic Development Manager Maribel Louie indicated that the first draft budget for Fiscal Year 2017 did not take into anticipated cost of living increases and would be reflected in the final draft budget. She also indicated that Visit West Hollywood has expressed interest in assuming management of the Sunset Strip Business Improvement District as it explores the feasibility of streamlining its marketing efforts while working in tandem with West Hollywood BIDS to aide in that effort. Staff's role would shift and all public relations services including media would be under the purview of Visit West Hollywood if approved by the Board and City Council. However, the City would maintain management of Block by Block security ambassador services and Social Vocational Services (street maintenance).

Chairman Maen and Vice Chair Latteri expressed interest in meeting with visit West Hollywood and requested that staff arrange the meeting.

**ACTION**: Approved the Sunset Strip Business Improvement District Budget for Fiscal Year 2017.

## B. Sunset Strip Street Light Pole Banner Policy

The Board received a presentation from staff on the Sunset Strip Street Pole Banner Policy and discussed nuances and next steps.

Arts and Economic Development Manager Maribel Louie indicated the Sunset Strip Street Pole Banner Policy allows for one banner sponsor or consortium of sponsor at any time for all banners spanning Sunset Boulevard between Doheny Road and ½ block west of Havenhurst. Typically, banners are expected to be replaced every 12 months. Revenue collected from the Sunset Strip street light pole banner sponsorship will be used to supplement the business improvement district.

Concerning next steps, staff will research legal options concerning the existing banner policy and speak Brown Forman about extending the banner program until a new sponsor is acquired. Ms. Louie suggested that the Board consider issuing a request for qualification for firm to work with the BID on obtaining sponsors for the Sunset Strip street light pole banners and that staff will provide a sample request for qualification for this type of service.

**ACTION**: By consensus, the Board requested that staff explore amending the Sunset Strip Street Light Pole Banner Policy to allow up to three (3) sponsors to be permitted at any time for banners spanning Sunset Boulevard and develop at fact sheet for potential sponsors that would include spec, stats and an image.
