Commissioner Coleman requested that the meeting be adjourned in the memory of the 49 individuals that were slain in Orlando.

Commissioner Sol requested that the meeting be adjourned in the memory of Mark Mitchell. Commissioner Sol also read the names of the 49 individuals that were slain in Orlando.

5. APPROVAL OF THE AGENDA

ACTION: Motion by Commissioner Williams to approve the June 13, 2016 agenda, seconded by Commissioner Sol, and approved.

POSTING OF THE AGENDA

The agenda for the June 13, 2016 Public Safety Commission meeting was posted at City Hall, Plummer Park, the West Hollywood Sheriff's Station, and the West Hollywood Library.

6. APPROVAL OF MINUTES

ACTION: Motion by Commissioner Waack to approve the May 9, 2016 minutes, seconded by Commissioner Williams, and approved.

7. PUBLIC COMMENTS

Luis Marquez, resident of West Hollywood, spoke regarding his concerns with criminal activity in his neighborhood and the lack of response by the Sheriff's Department.

David Eichman, resident of West Hollywood, spoke on behalf of the Transportation Commission and provided an update on recent and upcoming transportation projects. He spoke briefly about the new automated parking garage behind City Hall, the new bike lanes on Fairfax Avenue and launching the Bike Share program in the summer with 150 bikes and 20 bike stations.

Michael Wojtkielewicz, resident of West Hollywood, thanked Council, Sheriff's and Public Safety staff for their services and all the work they do on behalf of the residents.

Larry Block, resident of West Hollywood, pointed out that at this moment in time, all other issues pale in comparison to what happened in Orlando and what could have happened in West Hollywood if the Santa Monica suspect was not arrested. He also stated that there needs to be greater police presence in the community, especially around those businesses that operate late into the night.

Michael Dolan, resident of West Hollywood, thanked everyone for the additional deployment of Sheriff's on the east side. He spoke about an increased transient presence on the east side and about a specific incident that occurred with a transient on Greenacre. He also expressed concern that Sheriff's Dispatch told him that his address was in Los Angeles when he called to report the incident.

Yole Dore, resident of West Hollywood, congratulated the Captain and Public Safety on a successful PRIDE weekend and for keeping everyone safe. She spoke about an incident in a Russian market that she frequents where she was verbally assaulted because she was wearing the rainbow flag in support of the lives lost in Orlando.

Commissioner Williams made a recommendation to move the Public Safety Commission meetings back to City Hall starting with the July meeting.

Commissioner Waack reminded everyone about the Rainbow Key Awards on June 22, 2016.

Commissioner Williams congratulated Public Safety staff person, Laura Manukian, on her impending retirement. On behalf of the Commission she thanked Ms. Manukian for her service and presented her with a gift from the Commissioners.
