IV. UNFINISHED BUSINESS

A. Art on the Outside Subcommittee Report

The Commission received a report from the Art on the Outside Subcommittee on its meeting held May 26, 2016 and ratified recommendations proposed by the Subcommittee:

ACTION: Approve two artist exhibitions as proposed by LA><Art for the 9039 Sunset Strip Electronic Sign: Pascal Sisto (June 1-30) and Jen Liu (July 1-August 31); and approve an exhibition of work by artists Cole Sternberg for the 8041 Sunset Strip Electronic Sign from July 1-August 31 as proposed by LA><Art.

Motioned by Commissioner Beroukhim, seconded by Commissioner Carvalheiro and approved.

ACTION: Approve a proposed project at an amount not to exceed \$5,000 titled "The Cube" by Brazilian performer-composer Manuel Lima, current doctoral candidate at Cal Arts and Fulbright Scholar, for an installation/performance work to be sited on the Sunset Strip in August, pending public safety and building and safety reviews.

Motioned by Commissioner Beroukhim, seconded by Commissioner Lee and approved.

ACTION: Approve a six-month extension and a \$600 expenditure for cleaning of the sculpture "Eleven Holes" by artist Lisa Williamson in Kings Road Park.

Motioned by Commissioner Carvalheiro, seconded by Commissioner Moreno-Freedman and approved.

In addition, the Subcommittee reported that it is proceeding with developing a proposal for a new collaboration with the Museum of Neon Art for an installation of vintage neon signs to be sited on the medians at the intersection of Santa Monica Boulevard and Holloway Drive; and declined the revised proposal of the artwork "Burnt Forest: Drawing the Line" by artist Doron Gazit as part of the Can You Dig It? exhibition, due to concerns regarding safety and material integrity.

B. Performing Arts and Cultural Affairs Subcommittee Report

The Commission received a report from the Performing Arts and Cultural Affairs Subcommittee on its meeting held May 12, 2016 and considered ratifying recommendations proposed by the Subcommittee.

ACTION: Ratify approval of the City's 2017 Arts Grant Program General Applications and Guidelines (Arts Participation Grant, City Arts Project Grant Community Enrichment Grant, Cultural Resource Development Grant and One City One Pride Grant).

Motioned by Commissioner Dishman, seconded by Commissioner Moreno-Freedman and approved.

C. Urban Art Subcommittee Report

The Commission received a report from the Urban Art Subcommittee on its meeting held May19, 2016 and considered ratifying recommendations proposed by the Subcommittee.

ACTION: Approve Stage I Artist Approval of Michael McMillen for the project at 1041 N. Formosa (The Lot).

Motioned by Commissioner Dishman, seconded by Commissioner Moreno-Freedman and approved.

ACTION: Approve Stage II Schematic Design of project by artist Sterling Ruby for the Sunset/Doheny Hotel at 9040 Sunset Boulevard.

Motioned by Commissioner Lee, seconded by Commissioner Moreno-Freedman and approved, with Commissioner Dishman voting "No."

D. WeHo Arts: The Plan - West Hollywood Cultural Planning Process

The Commission received a report from the Performing Arts and Cultural Affairs Subcommittee, consultant Amanda Carlson and staff on the development of WeHo Arts: The Plan, the cultural planning process for the City of West Hollywood.

Staff reported that the Gray Malin artwork "Llamas & White Balloons" has been installed on the vertical billboard on Sunset Boulevard and that the urban art work by artist Janet Echelman for the Sunset/La Cienega project is to begin installation in September.
