## III. UNFINISHED BUSINESS

# A. Arts and Cultural Affairs Commission Review and Approval Process

The Commission reviewed and discussed the Arts and Cultural Affairs Commission Review and Approval Process and provide input and direction to staff as applicable.

Staff indicated that the ACAC Review and Approval Process is intended to develop comprehensive guidelines and criteria of quantitative and qualitative assessment methods for the City's various arts program as it pertains to the Commission's mission.

Commissioner Lee requested that staff review language on page and offered to provided staff with proposed revisions.

Staff will return with a revised verison for the July meeting.

# B. Art on the Outside Subcommittee Report

The Commission received a report from the Art on the Outside Subcommittee on its meeting held June 23, 2016 and consider ratifying recommendations proposed by the Subcommittee.

Subcommittee Chair Dishman reported that Subcommittee:

- Recommended approval of the revised proposal for the exhibition "The Chase" by HACER that called for the addition of two sculptures including one set of triple stacked cubed cates and one cube crate and budget not to exceed \$20,000 noting the cubed cates art integral to HACER'S artist statement.
- 2. Recommended approval of the temporary art proposal "Flavors of the Eastside: A Community Bread Bake" submitted by Community Arts Resources. Proposed project budget approximately \$7,350.
- 3. Declined the temporary art proposal by artist Maxwell Carracher. Proposed project budget approximately \$8,000.

Subcommittee Chair Candice Beroukhim reported the Subcommittee:

 Received a presentation from art consultant Patrick Ela on proposed artist Ned Kahn and Dora De Larios for the project at 9040 Melrose (Melrose Triangle). As a result, the Subcommittee recommended that the Arts and Cultural Affairs Commission approve Stage I Artist Approval of Ned Kahn and Dora De Larios for the urban art project at 9040 Melrose.

- Next Arts Pop-up is July 18, 2016 at Plummer Park.
- National Night August
- WeHo Arts the Plan Rack cards will be available soon.
- WeHo Talk Creative Space

The Commission also received an introduction to Social Practice Artists Alyse Emdur and Rosten Woo who spoke concerning the community engagement process. The teams plans to:

- Employ the unexpected
- Provide the community with takeaway art work that comes out of a unique experience
- Incorporate visioning activities
- Make the invisible visible
- Document cultural activities that exist in the community
- Develop project that gain community support and trust

The team expressed interest in finding specific communities in West Hollywod who are not being served by art but have shared interest in order to build a specific project and enforce the spirt of creativeity while providing awareness of WEHO Arts.

Following, Commissioners provided Emdur and Woo with suggestions on specific communities that they might engage as part of the social practice art component of The Plan. Specific communities included Sierra Bonita senior housing complex; West Hollywood

Community Housing Corporation; and young parents in West Hollywood Park as well as West Hollywood pocket parks.
