7. PUBLIC COMMENT

Josh Kurpies, from the Office of Assemblyman Richard Bloom, reminded the Board of the Senior Scam Stopper Seminar on June 24 at Plummer Park.

Marcy Norton, Chair of the Public Safety Commission, requested that the West Hollywood Taxi Subsidy Program designate Cedars Sinai Hospital as one of the destinations to which clients can receive the discounted rate.

A. ITEMS FROM SENIOR CENTER ACTIVITY PROGRAM

Nancy Desser, Director of Activities at the West Hollywood Comprehensive Services Center, announced some of the activities that are featured in the new Senior Spotlight.

B. <u>UPDATE ON THE PROCUREMENT OF NEW TRANSIT SERVICES</u> VEHICLES

Perri Sloane Goodman, Transportation Program Administrator, gave a presentation about the procurement of eleven new transit vehicles for the Cityline, Dial A Ride and TLC (Door to Door). She announced that the public will be able to preview the vehicles on Wednesday, July 13th from 10:30 AM – Noon at the Plummer Park lot.

C. SOVA FOOD PANTRY UPDATE

Fred Summers, Director of Operations at Jewish Family Service's SOVA Community Food & Resource Program, reported on recent changes in service. While the West Hollywood location closed on June 15, the vast majority of their 300+ clients will be served at the Pico/Robertson location, and others will utilize the new location at St. Thomas the Apostle Church. A member of the Board asked if volunteers are needed, and learned that there is always a need to supplement the work of the 200+ current volunteers.

John Allendorfer rode on the Gay Pride float as a representative of the senior community. He is interested in developing some projects with youth and seniors.

Pat Dixon suggested that Fairfax High School students become more aware of and involved with seniors.

Chair Walkup shared information about an LA Times article on senior health, the Gay Men's Chorus of LA concert with Cuban band Mano a Mano on June 25 & 26, and the upcoming GMCLA concert with Congregation Kol Ami's Rabbi Denise Eger in July, the statewide homeless emergency, medical disposal at the Sheriffs' locked drop boxes, and the new City budget of \$127 million.
