CALL TO ORDER: Chair Maggio called the meeting to order at 7:03 p.m.

### APPROVAL OF AGENDA:

Chair Maggio announced that the appeal for D-4115 has been removed from the agenda. A motion was made by Commissioner Sanes to approve the amended agenda for the August 25, 2016 meeting. The motion was seconded by Vice Chair Gregoire. The motion was approved (7-0-0).

# **APPROVAL OF MINUTES:**

Vice Chair Gregoire made a motion to approve the minutes of the August 11, 2016 meeting. The motion was seconded by Commissioner Sanes. The motion was approved (6-0-1) with Commissioner Harker abstaining.

# **Liaison Reports:**

Commissioner Harker provided a report regarding her attendance at the Disability Advisory Board meeting on August 24 and the Historic Preservation Commission meeting on August 22

Commissioner Gurfinkel provided a report regarding his attendance at the Russian Advisory Board.

Chair Maggio mentioned that he and Commissioner Sanes had attended a recent meeting of Chairs held by the City Manager.

# **UNFINISHED BUSINESS:**

Director Savage gave a report to the Commission on the topic of materials in multiple languages for outreach to the community's most vulnerable members. She provided a detailed report on the multiple levels of outreach that are done to reach and provide information to constituents, particularly those whose primary language is not English.

Margarita Kustanovich spoke about her personal experiences with outreach efforts to the Russian speaking community, as did Gloria Aviles regarding outreach to the Spanish speaking community.

Commissioner Bergstein commented on the customer service that is provided to the community by staff. He asked about ways to reach out to the Russian speaking community through the internet.

Commissioner Kurpies asked if the City had any data on how many West Hollywood residents use a computer. He asked about the information provided to the community through the Public Information Office.

Commissioner Harker spoke about public safety issues and who the community can reach out to when City Hall is closed.

Commissioner Gurfinkel commented on the level of outreach being done to the community. He also suggested additional methods the City can use.

# **COMMISSIONER COMMENTS:**

Commissioner Kurpies spoke about his participation in Councilmember Horvath's recent panel discussion on the topic of housing policies in the City of West Hollywood as well as how State policies affect City policy.

Chair Maggio, who had attended the housing policy meeting, spoke about some of the items that were discussed by the panel.

Commissioner Kurpies spoke about the launch of the WeHo Pedals bike share program.

Commissioner Harker announced the next RSO Building Blocks seminar entitled Reasonable Accommodations for Disabled Tenants will be held September 20, 2016.

Commissioner Bergstein asked for information on the Movietown seniors application process.
