A. REPORT FROM PHARMACEUTICAL PRICING SUBCOMMITTEE MEETING

The Board decided to postpone the Pharmaceutical Pricing Town Hall forum due to cancellations from panelists. In lieu of the forum, the Board unanimously voted to have staff research related legislative items and draft an item for the Board's review and action.

B. SUBCOMMITTEE FOR DISABILITIES AWARENESS MONTH

The Board received an update from the Disabilities Awareness Month subcommittee and approved their recommendations for the Health & Wellness Fair and the Disability Service Awards and televised meeting.

Tom Demille asked and received the Board's unanimous permission to distribute Social Services guides to the buildings operated by the West Hollywood Community Housing Corporation. Michael Wojtkielewicz thanked the Board for voting for his recommendations for Disability Service Awards. He requested an update on Councilmember Horvath's accessibility initiative. He spoke about internet services for low-income people.

Joy Freiberg asked that the topic of supportive employment programs be agendized and she received unanimous support from the Board on the future agenda item

Jim Chud has suggested to the bike share program that they include adult tricycles be added to the vehicles provided to the public.

Rick Watts announced that the National Association of Letter Carriers gathered two pallets of sample toiletries from their conference and distributed them to nine shelters. He asked that the meeting be adjourned in memory of Don Cannon, a long-time activist.

Chair Dore asked that the meeting also be adjourned in memory of David Street, a long-time cancer survivor.
