The Board will discuss co-sponsoring an upcoming City event in recognition and celebration of Black History Month, WE RISE! WE WRITE! WE ARRIVE!, a panel of outstanding women discuss their works of fiction and the stories that have inspired and influenced them. Boardmember Moore made a motion to co-sponsor the event and Boardmember Alexander seconded the motion. The motion was approved unanimously with Vice Chair Eyres abstaining.
