I. CALL TO ORDER

The Arts and Cultural Affairs Commission meeting was called to order by Commission Chair Madeleine Rackley at 5:05 pm.

C. Approval of the Agenda:

Commission Chair Rackley requested removal of Consent Calendar Item II.B. Street Media Update to the Excluded Consent.

Motioned approval of the October 27, 2016 agenda by Commissioner Dishman, seconded by Commissioner Beroukhim and approved.

II. CONSENT CALENDAR

The following routine matters were acted upon by one motion. Item II.B. was removed from the Consent Calendar by Commission Chair Madeleine Rackley for separate discussion under the Excluded Consent Calendar.

A. Posting of the Agenda

The agenda was posted per proper noticing procedures at City Hall, Plummer Park, West Hollywood Library and West Hollywood Sheriff's Station.

III. NEW BUSINESS

A. Arts Participation Grant - Queer Studies Caucus of the American Academy of Religion Western Region

The Commission reviewed an Arts Participation Grant Application submitted by the Queer Studies Caucus of the American Academy of Religion Western Region and considered awarding a grant in the amount of \$1,000 to support "Queer View – Religion and Identity in 2016" film festival featuring LGBTQ and religiously themed film shorts such as "Transmormon," "My Mother's Orphan" and "The HomoFiles."

ACTION: Approve an Arts Participation Grant award in the amount of \$1,000 to Queer Studies Caucus of the American Academy of Religion Western Region under the category to support "Queer View – Religion and Identity in 2016" film festival featuring LGBTQ and religiously themed film shorts.

Motioned by Commissioner Beroukhim, seconded by Commissioner Carvalheiro and approved.

B. Change to Commission By-Laws

The Commission considered a change to its by-laws regarding the location of its regularly scheduled meetings. The Commission felt the West Hollywood Library Community Meeting Room is more accessible to the public, technically equipped and more conducive for large-scale presentations. The Communuity Meeting Room also provides better facilitation of meetings and meeting space while providing higher visibility of the Arts and Cultural Affairs Commission and its subcommittees, similar to commissions that meet in the Council Chambers.

The Commission's request would be forwarded to City Council for its approval before the end of the year. Should Council approve change of location, it's aniticipated the Commission could begin meeting in the West Hollywood Library Community meeting room in the New Year.

ACTION: Recommend changing the by-laws for the regularly scheduled Commission meetings from the Community Conference Room in City Hall to the Community Meeting Room of the West Hollywood Library and forward recommendation to City Council for approval.

A. Art on the Outside Subcommittee Report

The Commission received a report from the Art on the Outside Subcommittee on its meeting held October 27, 2016 and considered ratifying recommendations proposed by the Subcommittee.

B. Performing Arts and Cultural Affairs Subcommittee Report

The Commission received a report from the Performing Arts and Cultural Affairs Subcommittee Report on its meeting held October 13, 2016 and considered ratifying recommendations proposed by the Subcommittee including funding the 2017 City's Arts Grant programs and approval of 2017-2018 Winter and Summer Sounds musicians and bands.

Arts Manager Andrew Campbell provided an overview of the Arts Grants Program, peer review process and budget allocations for each grant program for Year I, Year II and Year III.

Commissioner Rackely recused herself prior to discussion and approval of City Arts Project Grants.

Arts Manager Andrew Campbell requested the Commission consider funding the Los Angeles Nomadic Division (LAND) in the amount of \$7,000. He indicated upon review of Year II (2017) City Arts Project Grant funding allocations, he noticed a 2016 grant recipient applied for one year of funding. Thus, the organization would not be eligible to receive funding in 2017. Therefore, a \$7,000 surplus exist in the Year II (2017) City Arts Project Grant. He indicated that the Commission could fund the organization as requested by staff or allocate the funds to another program(s) as needed.

ACTION: Approval of funding allocations based on scores provided by the arts grant peer review and as recommended by the Performing Arts and Cultural Affairs Subcommittee to include the award of City Arts Project Grants totaling \$91,500 to twelve (12) arts organizations at various levels as indicated below and including LAND.

Commission Chair Rackley returned to the dais to discuss funding allocations for Cultural Resource Development Grants.

ACTION: Approval of funding allocations based on scores provided by the arts grant peer review panel and as recommended by the Performing Arts and Cultural Affairs Subcommittee to include the award of Cultural Resource Development Grants totaling \$12,000 or \$4,000 each of which \$2,500 cash award and \$1,500 for technical assistance consultancy to three (3) arts organizations at four thousand dollars each including as indicated below:

Arts Coordinator Michael Che provided an overview of the One City One Pride Arts Grant Program including the theme for 2017 (Go West), the peer review process and budget allocation. He indicated that performance artists Yozmit Walker and MJ Brown aka Miss Barbie Q could be funded through the City's Transgender Arts Inititative. Both artists identify as trans. However, it is unclear if both identify as transgender.

It was the consensus of the Commisson to fund performance artist MJ Brown aka Miss Barbie Q through One City One Pride rather than through the City's Transgender Arts Initiative. Thus, only performance artist Yozmit Walker would be funded through the City's Transgender Arts Initiative.

ACTION: Approval of funding allocations based on scores provided by the arts grant peer review panel and as recommended by the Performing Arts and Cultural Affairs Subcommittee to include the award of One City One Pride Grants totaling \$35,000 to seven (7) arts organizations/individual artists and the award of Transgender Arts Initative funds totaling \$6,750 (\$6,750 each) to two (1) individual artists as as indicated below.
