The Commission received a report from the Art on the Outside Subcommittee on its meeting held July 28, 2016 and considered ratifying recommendations proposed by the Subcommittee.

ACTION: Ratify recommendations proposed by the Subcommittee including:

 Approval of the temporary art project proposal by LA><ART for an exhibition featuring works by artist Martine Syms for installation on the electronic billboard at 1OAK, 9039 Sunset Blvd from September 1 – October 31, 2016 in accordance with the temporary art proposal review criteria.

Motioned by Commissioner Beroukhim, seconded by Commissioner Lee and approved.

- Approval of the temporary art project proposal by LA><ART for an exhibition featuring works by artist Amy Jorgensen for installation on the electronic billboard at 8410 Sunset Blvd from September 1 October 31, 2016.
 Motioned by Commissioner Beroukhim, seconded by Commissioner Carvalheiro and approved.
- Approval of the temporary art project proposal by LA><ART for an exhibition featuring works by artist Basma Alsharif for installation on the electronic billboard at 8410 Sunset Blvd from November 1 – December 31, 2016 to the Arts and Cultural Affairs Commission. Motioned by Commissioner Beroukhim, seconded by Commissioner Carvalheiro and approved.
- Approval of a Commercial Business Mural Application submitted by The Stand on Sunset at 8224 W. Sunset Blvd featuring a work by an unknown artist as art and not creative signage. Motioned to approve by Commissioner Williamson, seconded by Commissioner Rackley and approved.

B. Performing Arts and Cultural Affairs Subcommittee Report

The Commission received a report from the Performing Arts and Cultural Affairs Subcommittee on its meeting held July 14, 2016 and considered ratifying recommendations proposed by the Subcommittee.

Subcommittee Committee Chair Rackley reported at the meeting the Subcommittee:

- Continued discussion on marketing and programming opportunities in association with The Getty's 2017 initiative PST: LA/LA (see Item III.D).
- Continued discussion on the development of the cultural planning process with Social Practice Artists Alyse Emdur and received a status update from consultant Amanda Carlson. It is anticipated that the social practice component would take place in September October with a much larger event in November.
- Reviewed and recommend that the Arts and Cultural Affairs Commission approve
 panelists and list of potential panelists for the City's 2017 Arts Grant Program and
 One City One Pride grant program and authorize staff to make modifications to
 the panels as needed.
- Discussed Performing Arts and Cultural Affairs projects under the Subcommittee's oversight.
- Discussed potential partnership/collaboration opportunities between the Arts and Cultural Affairs Commission/City with the Wallis Annenberg Center for the Performing Arts in Beverly Hills. As a result, Arts Administrator Andrew Campbell suggested a meeting with Commissioner Moreno-Freeman, City staff and Debra Pasquerette, Manager of Community Engagement at the Wallis Annenberg Center for the Performing Arts. It was also suggested that the Commission invite Ms. Pasquerette to a Commission meeting.

ACTIONS:

 Ratify the Subcommittee's recommendation and approve a list of potential panelists for the City's 2017 Arts Grant Program and One City One Pride grant program and authorize staff to make modifications to panels as needed.
 Motioned to approve by Commissioner Lee, seconded by Commissioner Moreno-Freedman and approved.


C. Urban Art Subcommittee Report

The Commission received a report from the Urban Art Subcommittee on its meeting held July 21, 2016 and considered ratifying recommendations proposed by the Subcommittee.

Subcommittee Chair Beroukhim reported the Subcommittee reviewed Stage II Schematic Plan for the urban art project at 8017 Norton Avenue; 563 Alfred Street and 8350 Santa Monica Boulevard and recommended that the Commissionn ratify the following recommendations:


ACTIONS:

 Approve Stage II Schematic Plan by artist Heath Satow for the urban art project at 8017 Norton Avenue.




Motioned by Commissioner Lee, seconded Carvalheiro and approved.

• Approval Stage II Schematic Plan by artist Monique Van Genderen for the urban art project at 8350 Santa Monica Boulevard.



Motioned by Commissioner Beroukhim and seconded by Commissioner Williamson and approved.

D. PST: LA/LA

The Commission continued its discussion on marketing and programming opportunities in association with The Getty's 2017 initiative PST: LA/LA, and consider awarding a grant not to exceed \$20,000 during fiscal year 2016-17 to Rogue Artists Ensemble to begin work on "Senor Plummer," a multidisciplinary theatrical work to be presented as part of PST: LA/LA in West Hollywood in September 2017. The Commission will consider an additional award of \$20,000 for fiscal year 2017-2018, upon evaluation of the first year grant progress.

Commssioner Rackley reported the Subcommitteee discussed the theatre/performance project "Senor Plummer" with Rogue Artists Ensemble Artistic Director Sean Cawelti and staff to be presented as part of the PST LA/LA project in fall 2017.

As a result of its discussion, the Subcommittee requested Rogue Artist Ensemble draft a proposal detailing thoughts, theme and ideas to be expressed through the work including genre, structure and overall framework of the play in addition to character development as well as visual and environmental elements of the work. Additionally, the Subcommittee requested production budget scenarios at various levels and scope. The Subcommittee also recommended that at minimum there be a public performance deliverable at the \$20,000 level, should the Commission elect not to provide the second year grant.

ACTION:

Ratify the Subcommittee's recommendation and approve \$20,000 from FY2017 Budget to support the development of the original theatrical production about "Senor Plummer" based on the book <u>Senor Plummer: The life and laughter of an Old-Californian</u> and other historical documents in collaboration with Rogue Artist Ensemble to include a draft proposal detailing thoughts, theme and ideas to be expressed through the work; genre, structure and overall framework of the play; character development; visual and environmental elements of the work; and production budget scenarios at various levels and scope noting that at minimum there must be a public performance deliverable at the \$20,000 level.

Motioned by Commissioner Williamson, seconded by Commissioner Lee and approved.

E. WeHo Arts: The Plan – West Hollywood Cultural Planning Process

Motion by Commissioner Lee, seconded by Commissioner Berhoukhim and approved.

B. Election of Vice-Chair - FY2017

The Commission considered electing a Vice Chair to preside over the Arts and Cultural Affairs Commission in absence of the Chair and in accordance with the ACAC Bylaws.

ACTION: Elect Commissioner Lee as Vice Chair to the Arts and Cultural Affairs Commission in accordance with the ACAC Bylaws.

Motion by Commissioner Rackley, seconded by Moreno-Freedman and approved.

V. EXCLUDED CONSENT

A. Public Art Network Pre-Conference, Americans for the Arts 2016 Annual Convention

The Commission received and filed a report from Public Art Coordinator, Rebecca Ehemann about her experience at the Public Art Network Pre-Conference, Americans for the Arts 2016 Annual Convention.

Commissioner Rackly requested staff include as part of the cultural planning process the topic of decommissioning and permanency of public art as it pertains to the City's Percent for Art Ordinance.

Commissioner Lee requested that the Commission consider exploring the feasibility of working and/or providing opportunities for public art grad students to futher their education while assisting the City with its strategies around public art and community engagement.
