# ARTS AND CULTURAL AFFAIRS COMMISSION MEETING MINUTES

#### I. CALL TO ORDER

## A. Art on the Outside Subcommittee Report

The Commission received a report from the Subcommittee Chair J. Dallas Dishman on its meeting held September 22, 2016 and considered ratifying recommendations proposed by the Subcommittee including:

#### **ACTIONS:**

- 1. Approval of the mural, "Floralpiece" by artist Maria Pineres to the Arts and Cultural Affairs Commission as art and not creative signage for installation at 8711 Melrose Avenue.
  - Motioned by Commissioner Lee, seconded by Commissioner Carvalheiro and approved unanimously.
- 2. Approval of 15 artist applications for inclusion on the West Hollywood Muralist Roster, and authorize staff to utilize the West Hollywood Muralist Roster as the source for the artist selection for the temporary public art opportunity on the construction fence at 8120 Santa Monica Boulevard.

- 3. Approval of proposed site locations for PST: LA/LA "Cube" project by LAND.

- 4. Approval of using the digital billboards at 10AK and across from the Andaz for a period of 3 months for PST: LA/LA digital art projects as curated by LA><ART and the Getty.

## **B. Urban Art Subcommittee Report**

The Commission received a report from the Urban Art Subcommittee on its meeting held September 15, 2016 and consider ratifying recommendations proposed by the Subcommittee including:

- 3. Approval of Stage II Schematic Design by artist Michael McMillen for the urban art project at 1041 N Formosa (The Lot) to the Arts and Cultural Affairs Commission in accordance with the City's Urban Art Policy and Guidelines.

- 4. Approval of Stage III Final Art Plan for the urban art project by Heath Satow at 8017 Norton Avenue to the Arts and Cultural Affairs Commission in accordance with the City's Urban Art Policy and Guidelines.

## C. WeHo Arts: The Plan - West Hollywood Cultural Planning Process

The Commission received a report from Performing Arts and Cultural Affairs Subcommittee members Madeleine Rackley and Cat Lee, consultant Amanda Carlson and staff on the development of WeHo Arts: The Plan, the cultural planning process for the City of West Hollywood. Cat Lee related some of the things she learned at the pop-up sat Scrumptious Café, including that people still had a hard time finding information about art events, and that the people in attendance really seemed to like the Shana Mabari Illuminated sculptures. Commissioner Williamson suggested ordering swag for the pop-ups that promote the social media handle @wehoarts so people will know where to go for more information.

#### D. PACIFIC STANDARD TIME: Latin America/Latino Art (PST: LA/LA)
