Scope of Work:

The City seeks proposals from interested and qualified civil engineering firms, licensed in the State of California, for the preparation of conceptual alternative layout plans for usage by City staff in community meetings as well as final bid documents, specifications, and cost estimates for the construction of a new cul-de-sac on Havenhurst Drive at the City boundary, south of Sunset Blvd. The new cul-de-sac shall be equipped with siren activated retractable bollards for emergency vehicle access. The selected consultant will be responsible for organizing a project team with expertise in preparation of civil, striping & signage, landscape/irrigation, and lighting/electrical plans, specifications, and cost estimates. Topographical surveying to produce the base map, utility research of substructures in the vicinity of the work, and plan approval from the LA County Fire Department will need to be done.
