- **1. CALL TO ORDER:** Chair Aghaei called the meeting of the Planning Commission to order at 6:32 P.M.
- 2. PLEDGE OF ALLEGIANCE: Sybil Zaden led the Pledge of Allegiance.

4. APPROVAL OF AGENDA.

Move New Business Item 11.A. – Design Review Subcommittee Appointment before Public Hearing Item 10.A.

ACTION: Approve the Planning Commission Agenda of Thursday, January 19, 2017 as amended. **Moved by Commissioner Altschul, seconded by Commissioner Jones and unanimously passes.**

5. APPROVAL OF MINUTES.

Yvonne Quarker, City Clerk stated the City Clerks Association of California has developed guidelines for official minutes for all governmental agencies. The City of West Hollywood has adopted the format for very minimal brief summary action minutes that all commissions, boards, as well as city council will now be following.

ACTION: Approve the Planning Commission regular meeting minutes of: 1) Thursday, December 1, 2016; and 2) Thursday, December 15, 2016, as presented. **Moved by Commissioner DeLuccio, seconded by Commissioner Jones and passes, noting Vice-Chair Buckner abstaining on the minutes of Thursday, December 15, 2016.**

6. PUBLIC COMMENT.

MICAHEL WOJTKIELEWICZ, WEST HOLLYWOOD commented on the 2017 Council Candidate Forum for the City of West Hollywood.

LYNN HOOPINGARNER, WEST HOLLYWOOD, Vice-President of West Hollywood North Neighborhood Association, commented on non-compliance with zoning codes.

STEVE MARTIN, WEST HOLLYWOOD commented on the future and direction of the City of West Hollywood.

ROXANNE MC BRIDE, WEST HOLLYWOOD commented on the Eastside of West Hollywood and its future identity.

7. DIRECTOR'S REPORT.

John Keho, Assistant Director, Community Development Director presented the Director's Report.

He provided a three month review update on Catch Restaurant. He stated there have been three notices of violations: 1) no special event permit was procured for their opening night party; 2) outdoor smoking - no smoking operations plan; and 3) noise concerns.

Staff met with Catch Restaurant representatives and they have agreed to: 1) reposition all speakers on the patio, and reduce the base of the speakers, 2) agreed to hire extra security to deal with valet noise and paparazzi; 3) cap all processors by zone to reduce all speaker capacity; 4) post additional signs asking patrons to be quiet and respect the neighbors; 5) agreed to hire a local sound specialist to do an additional acoustical study; and 6) agreed to hourly sound checks; by standing in the driveways of residential properties on Rangely Drive.

Staff suggested the valet operation be moved from the street to inside the garage after midnight. Another review will take place in three months.

Commissioner Lightfoot questioned how Catch Restaurant could have valet parking on the street, when they specifically said at the public hearing that it would be inside the garage. She also questioned the retractable roof.

John Keho, Assistant Director, Community Development Director stated the valet parking plan was not conditioned as part of the action. Therefore, staff permitted them the on-street valet permit at that time. It is now being revisited and has moved back into the parking garage as a test.

8. ITEMS FROM COMMISSIONERS.

Commissioner DeLuccio clarified the reasoning of the denial for the zone text amendment regarding corporate rentals.

10. PUBLIC HEARINGS.

Commissioner Altschul recused himself from the meeting at this time; due to living within 500' of the proposed project site, located at 1114 N. Horn Avenue, West Hollywood, California.

Vice-Chair Buckner recused herself from the meeting at this time; due to living within 500' of the proposed project site, located at 1114 N. Horn Avenue, West Hollywood, California.

THE COMMISSION TOOK A FIVE (5) MINUTE RECESS AT 7:15 P.M. AND RECONVENED AT 7:20 P.M.

A. 1114 N. Horn Avenue (Chalk Preschool):

Rachel Dimond, Senior Planner provided a verbal and visual presentation and background information as presented in the staff report dated Thursday, January 19, 2017.

Applicant is requesting a child day care center with a new proposed parking lot, with an outdoor playground. The existing building would be renovated with four classrooms on the first floor, an indoor play area, lounge and office space. On the second floor there would be administrative space with offices and a lounge.

She stated the school would accommodate seventy-three students in four class rooms, and would have full and half day programs. Drop-off times would be 7:30 a.m. to 9:30 a.m. for full programs, and 8:30 a.m. to 10:30 a.m. for half programs. Pick-up times would be 2:30 p.m. to 5:30 p.m. for full programs, and 11:30 a.m. to 12:30 p.m. for half programs.

Neighborhood concerns included noises from outdoor play area, traffic, pick up/drop off, limitations on other uses, sex offender proximity, and if this item is a permitted use in the Sunset Specific Plan.

Staff recommended conditions regarding noise: 1) outdoor play area shall not be used for outdoor play before 9:30 a.m. daily; 2) no outdoor amplified sound is permitted, teachers and staff are not permitted to utilize whistles, bells, or any amplified sound devices outside on the playground or in the parking lot; and 3) no more than 25 children may be outdoors in the play area at any time.

She detailed the traffic concerns and spoke regarding traffic comparisons between preschools, retail, restaurants, offices, and bars. She further clarified the parking lot situation and pick-up and drop-off requirements.

The commission questioned staff regarding prohibited future uses, outdoor music, adverse impacts on the school, advertising, alcohol and tobacco sales in proximity to the school, noise ordinance enforcement, daily trips, parking attendant, number of students per program, number of review periods, and total number of employees.

Commissioner Jones had no official disclosures.

Commissioner DeLuccio disclosed for the record he had a conversation with West Hollywood resident Jerome Cleary. Everything discussed was in the staff report.

Chair Aghaei disclosed for the record he had a conversation with West Hollywood resident Jerome Cleary. Everything discussed was in the staff report.

Commissioner Lightfoot had no official disclosures.

Chair Aghaei opened the public hearing for Item 10.A.:

DOUG OLEFF, LOS ANGELES, owner, Chalk Preschools, presented the applicants report. He spoke on the history of Chalk Preschool and detailed the location, parking requirements, outdoor play requirements, demographics, traffic impacts, and noise concerns.

BJOYN SCHRADER, CULVER CITY, architect, continued the applicants report. He spoke on the lack of preschools in the area, traffic concerns, and detailed the current sites condition.

ANGELA JOHNSON, PLAYA VISTA, Executive Director, Chalk Preschools, continued the applicants report. She detailed the number of classrooms, number of children on the playground, and drop-off times.

The commission questioned the applicant regarding traffic circulation; ingress and egress into the site, neighborhood meetings, parking concerns and parking attendant, school hours, demographics, and alternative playground area.

DOUG OLEFF, LOS ANGELES, owner, Chalk Preschools, presented the applicants rebuttal. He spoke regarding traffic circulation, parking concerns, and commented on the supposed discrimination of families and children in West Hollywood.
