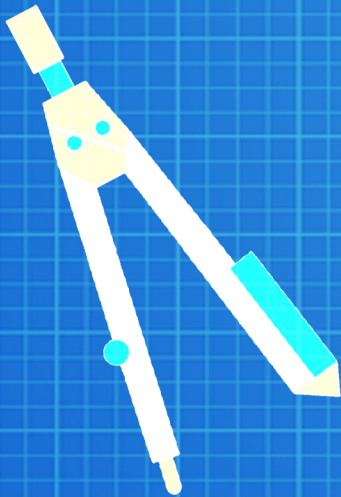

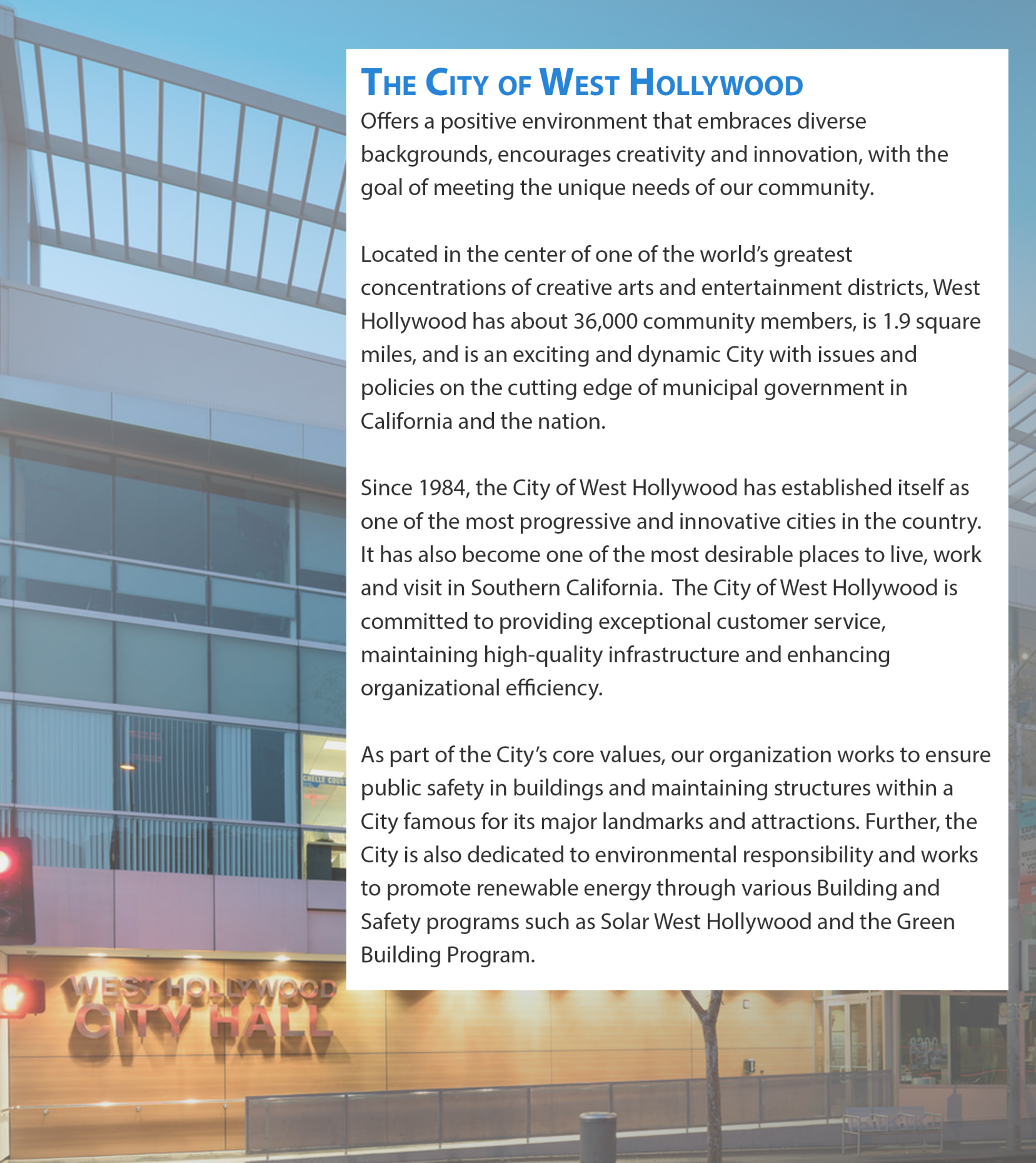
THE CITY OF WEST HOLLYWOOD

The Division

The Building and Safety Division is responsible for enforcement of codes and regulations through the permit and plan check review process, inspection of construction projects and providing direct assistance to the West Hollywood community. The Division is also responsible for enforcement of the

California State accessibility regulations and energy conservation regulations. Additionally, the Building and Safety Division administers programs such as Solar West Hollywood, WeHo Seismic Retrofit Program and Green Building Program.

The Position

The Senior Plan Check Engineer reports to the Building and Safety Manager/Building Official and conducts complex, technical reviews of architectural, structural, building plans for residential and commercial structures, ensuring compliance with codes, local ordinances and

governmental requirements. This position is responsible for over-the-counter plan check services and will interact with a variety of high level individuals, including architects, engineers, developers and design professionals.

The Ideal Candidate

- Experienced in reviewing architectural, structural, building plans for code and regulatory compliance
- Proficient in interpreting and handling various types of complex plans, documents and building code issues and questions
- Knowledgeable of CalGreen and Energy Compliance Standards
- Strong interpersonal skills in working with various groups of individuals internally and externally

The Qualifications

- Bachelor's degree from an accredited four-year college or university in Civil or Structural Engineering, Architecture, or a related field; and,
- Five (5) to seven (7) years of progressively responsible experience in reviewing plans, plan checking, and project management; or,
- Any combination of education, training and experience which provides the required knowledge, skills, and abilities to perform the essential functions of the job.
- ICBO/ICC Certified Plans Examiner
- Valid Registration as a Professional Civil Engineer in California

The Compensation

The salary for this position is within an established monthly range of \$8,407 - \$10,742 , and will be dependent upon the qualifications and experience of the selected candidate.
