The Commission considered ratifying the Urban Art Subcommittee's recommendation to conserve and remake eleven signs that comprise the art installation *Regard*. by artist Rebecca Lowry, at a cost not to exceed \$1,500, and to accept the work into the City's permanent civic art collection.

B. Performing Arts and Cultural Affairs Subcommittee Report

The Commission received a report from the Performing Arts and Cultural Affairs Subcommittee on its meeting held May 11, 2017 and considered ratifying recommendations proposed by the Subcommittee.

- 2. Approval of an Arts Participation Grant of \$1,000 to Being Alive People with AIDS Action Coalition to support a pottery/ceramic workshop culminating in an exhibition of works by coalition participants. **Approved as part of the Consent Calendar.**
- 3. Approval of the recommended budget scenario totaling \$180,000 total (\$100,500 in already committed funds and \$79,500 for new grants including a new pilot individual artist grant category consisting of 4 grants in the amount of \$2,000 each.) Approved as part of the Consent Calendar.

The Commission received a report from the Art on the Outside Subcommittee on its meeting held May 25, 2017 and considered ratifying recommendations proposed by the Subcommittee.

ACTION: Approval of Stage I – Artist Approval of artists Teresita Fernandez, Phillip K. Smith, III, and Swarovski artist collaborator and Mark Hagen to submit concept designs for consideration for the urban art project at 8432 & 8420 Sunset Boulevard and noting should the developer recommend Swarovski artist collaborator, the Subcommittee would need to approve the selected artist.
