V. COMMISSION CONSIDERATION

A. Consider Aprroving A Taxi Meter Rate Increase And Approving The Annual Taxi Franchise Agreement

Recommendation:

- 1. Approve staff's recommendation to increase West Hollywood taxicab meter rates to those established by the City of Los Angeles Department of Transportation Taxi Commission which became effective August 11, 2008:
 - Increase current drop charge of \$2.20 for the first 1/11th mile or 30 seconds to \$2.85 for the first 1/9th mile or 30 seconds of waiting.
 - Increase current distance charge of \$.20 each additional 1/11 mile (equivalent to \$2.20 per mile) to \$.30 each additional 1/9th mile (equivalent to \$2.70 per mile).
 - Increase waiting/time delay charge from \$.20 for each 36 seconds (equivalent to \$20.00 per hour) to \$0.30 for each 37 seconds waiting time or traffic delay (equivalent to \$29.19 per hour).
- 2. Increase flat rate to LAX from \$35.00 to \$40.00.
- 3. Direct staff to draft a resolution indexing future taxicab rate increases to those established by the City of Los Angeles DOT Taxi Commission.
- 4. Approve the establishment of a Transportation Program Enhancement Fee of \$270.00 per vehicle at the renewal of the franchise period.
- 5. Increase reimbursement of taxi coupons from 90% of value to 100% of value.

6. Direct staff to enhance Dial-A-Ride program utilizing the balance of funds available from the Transportation Program Enhancement Fee.
