### V. COMMISSION CONSIDERATION

A. **Bicycles on Sidewalks Recommendation: That the Transportation Commission support staff recommendation and forward the following recommendations to the City Council for final action:**

1. **To revise the Municipal Code to:**
  - **Prohibit the operation of bicycles on the sidewalks where there are designated bicycle lanes; and**
  - **Permit the operation of bicycles on the sidewalk where there are no designated bicycle lanes but enforce the willful or wanton disregard of any bicyclist for the safety of pedestrians or property; and**
  - **Require bicyclists to meet the requirements of the California Vehicle Code relating to registering, operating and equipping bicycles; and**
  - **Authorize the West Hollywood Sheriff to actively enforce the Ordinance; and**
2. **At the adoption of revisions and prior to the active Sheriff enforcement of the Municipal Code relative to the operation of bicycles:**
  - **Commence a one month public notice and “warning” period; and**
  - **Post signage/street markings at appropriate locations advising of the City’s bicycling on the sidewalk regulations; and**
3. **Support for ongoing public programs related to bicycling in the City**
  - **Encourage CDD and Public Safety Division staff and Sheriff Bicycle Patrol to prepare bicycle awareness campaign to promote bicycle safety citywide; and**

- **Encourage staff to identify and sign alternative bicycle routes that would guide bicyclists to City streets with less vehicle traffic.**
