**NOTICE IS HEREBY GIVEN** that the West Hollywood Planning Commission will hold a Public Hearing to consider the following item:

**LOCATIONS:** CITYWIDE, West Hollywood, California

**REQUEST:** The Planning Commission will hold a public hearing to consider a recommendation to the City Council regarding changes to Title 19 of the West Hollywood Municipal Code regulating cannabis- related land uses as allowed under state law, including the following uses: adult-use retail sales, medical-use dispensaries, cannabis deliveries and cannabis consumption areas for on-site consumption and ancillary uses as permitted under existing code requirements.

This zone text amendment is being processed concurrently with changes to Title 5 of the West Hollywood Municipal Code related to changes to the City's business license ordinance for cannabis related businesses.
