# B. Performing Arts and Cultural Affairs Subcommittee Report

## A. Tierra del Sol Foundation

The Commission received a presentation from President and Chief Executive Officer Rebecca Lienhard and from Tierra del Sol Foundation on their work to empower people with disabilities to achieve their potential and desire to become productive citizens who are accepted, included, and valued for the contributions they make to the economic, civic and cultural vitality of the community."

Tierra del Sol Foundation expressed interest in working with the City to provide artists with disabilities with more exposure, greater art opportunities and workspace (satellite studio) in West Hollywood.

## C. WeHo Arts: The Plan

The Commission reviewed cultural plan priorities and recommendations with consultant Amanda Carlson and provided direction on the implementation of *WeHo Arts: The Plan* through its 2018-2020 Work Plan.

In response to Ms. Carlson's question concerning what worked well during the cultural planning process, it was the consensus of the Commission that the process, numbers of persons reached and variety of methods used to obtain quality information from residents and visitors very beneficial. It was also the consensus of the Commission that the plan is useable and highly flexible.

Ms. Carlson requested that commissioners keep in mind the following questions for subsequent discussion on the implementation of WeHo Arts: The Plan:

- 1. How would the Commission like to continue over the next several months?
- 2. What are the Commission's implementation expectations?
- 3. How would the Commission like to receive information, communicate its decisions and continue its engagement with the community?
- 4. How does the Commission envision The Plan influencing City policy, initiatives, and the work plans of other City departments?
- 5. What could we do better?

Ms. Carlson announced that data visualization artists Maria Lamadrid, Sean Noyce and YoMeryl will be present at the September 28, 2017 meeting.
