4. NEW BUSINESS

A. Red Light Photo Enforcement Program Update

Recommendation: Support the Public Works Department's recommendation for the continued operation of the Red Light Photo Enforcement Program, including the enforcement of right turns on red when

the vehicle speed exceeds 15 miles per hour or exceeds 10 miles per hour when the Los Angeles County Sheriff's Department identifies public safety concerns.

B. Citywide Bike Share Program Update

Recommendation:

1. Receive an update on the first year of operations for WeHo Pedals Bike Share and next steps in establishing regional interoperability.
2. Provide feedback to staff on a proposed pilot dockless bike share program.

C. Test Turn Restrictions at the San Vicente Boulevard/ Rosewood Avenue and La Cienega Boulevard/Rosewood Avenue Intersections

Recommendation: Recommend to the City Council:

- 1) Six-month test turn restrictions at the San Vicente Boulevard and Rosewood Avenue intersection:
 - a. Prohibiting southbound San Vicente to eastbound Rosewood vehicle movements 4p.m.-7p.m. weekdays,
 - b. Prohibiting westbound Rosewood to southbound San Vicente vehicle movements at all times.
- 2) Direct staff to work with the City of Los Angeles to achieve a joint agreement for a six-month test for turn restrictions at the La Cienega Boulevard and Rosewood Avenue, a shared intersection:
 - a. Prohibiting southbound La Cienega to westbound Rosewood vehicle movements during 7a.m.-10a.m. weekdays,
 - b. Prohibiting northbound La Cienega to westbound Rosewood vehicle movements during 7a.m.-10a.m. weekdays,
 - c. Prohibiting left and through vehicle movements from the east and west approaches of Rosewood Avenue to La Cienega Boulevard during 7a.m.-10a.m. weekdays.

D. 500 Block Of Westbourne Drive Test Speed Lumps

Recommendation: Recommend to the City Council the test implementation of speed lumps on the 500 block of Westbourne Drive.
