I. CALL TO ORDER

B. Performing Arts and Cultural Affairs Subcommittee Report

The Commission received and filed a report from the Performing Arts and Cultural Affairs (PACA) Subcommittee on its meeting held October 12, 2017.

ACTION: Ratified the Performing Arts and Cultural Affairs Subcommittee's recommendation to approve a WeHo Arts Community Grant award of \$1,000 to MEDIARAMA Inc. **Approved as part of the Consent Calendar.**

C. Urban Art Subcommittee Report

No reportable action was taken during the Urban Art Subcommittee at its meeting held October 19, 2017.

III. UNFINISHED BUSINESS

A. Art on the Outside Subcommittee Report

The Commission received a report from the Art on the Outside Subcommittee on its meeting held October 26, 2017 and considered ratifying recommendations proposed by the Subcommittee.

Commissioner Dishman reported that the Art on the Outside Subcommittee reviewed five curators who had responded to the Santa Monica Boulevard/Doheny Drive Sculpture Park Curator Proposals. The Subcommittee narrowed their search down to three curators, and directed staff to extend an invitation to the selected curators, Aurora Tang, Peter Mays (Los Angeles Artist Association), and Emily Womack (Dyson & Womack), to attend the next Subcommittee Meeting to present their work and proposal to the Subcommittee.

The Subcommittee directed staff to create a RFP to program the 9x9 mural space in the ground floor of the West Hollywood Park Parking Structure currently displaying Mei Xian Qiu's "Let a Thousand Flowers Bloom; 8990."

Commissioner Dishman reported that the Art on the Outside Subcommittee approved a temporary video art project proposal from IF (Innovation Foundation), "Goldfoss-Episodes" by artist Sita Valrún, for installation on the electronic billboard at 9039 Sunset Boulevard from November 1, 2017 – December 31, 2017.

ACTIONS: Ratified the Art on the Outside Subcommittee's recommendation to approve the temporary video art project proposal from IF (Innovation Foundation) for

"Goldfoss-Episodes" by artist Sita Valrún for installation on the electronic billboard at 9039 Sunset Boulevard from November 1, 2017 – December 31, 2017.

A. Study Session: Cultural Facilities and Artists Housing

The Arts and Cultural Affairs Commission convened to a Study Session, where City staff presented updates on cultural capital projects in the City, including West Hollywood Park Phase II and the Werle Building – and how art is to be integrated into these capital projects. The Commission also discussed potential opportunities to develop cultural facilities in private and public developments, and the potential to develop artist housing in West Hollywood. As part of the Study Session, the Commission received comments from Helen Collins, Senior Administrative Analyst, Facilities and Field Services Division; Joanna Hankamer, Principal Planner, Capital & Special Projects; Peter Noonan, Rent Stabilization and Housing Manager; Bianca Siegl, Long Range and Mobility Planning Manager and David DeGrazia, Current and Historic Preservation Planning Manager.

B. Study Session: Sarah Conley Odenkirk – How to Approve and/or Deny Project Proposals Using the Review and Evaluation Criteria

The Arts and Cultural Affairs Commission convened to a Study Session. As part of the Study Session, the Commission received a presentation and comments from Lawyer Sarah Conley Odenkirk on how to use the newly established Art on the Outside Subcommittee Review and Evaluation Criteria to approve and/or deny projects. Odenkirk's presentation stressed the importance of understanding the first amendment and its relationship to public art.
