# CITY OF WEST HOLLYWOOD ARTS AND CULTURAL AFFAIRS COMMISSION MINUTES

# THURSDAY, SEPTEMBER 28, 2017 - 5:00 P.M.

#### I. CALL TO ORDER

The Arts and Cultural Affairs Commission meeting was called to order by Commission Chair Catherine Lee at 5:05 p.m.

#### II. CONSENT CALENDAR

#### III. UNFINISHED BUSINESS

## A. Public Fiction Project

The Commission received an update from curator Lauren Mackler regarding the Public Fiction project, publication, Artist's TV commercials, and the 2018 exhibition at the MAK Center for Art and Architecture.

#### B. WeHo Arts: The Plan

The Commission received an update from Cultural Planning Consultant Amanda Carlson on the implementation strategy for *WeHo Arts: The Plan*.

Ms. Carlson requested that the Commission save the date of Saturday November 4, 2017 from noon to 2 p.m. for the *WeHo Arts: The Plan* Launch Party. The event will be held on the Lawn at Plummer Park. She announced the event *Common Field Convening Los Angeles* an itinerant annual gathering that brings together 350+ local and national organizers to explore the state of the field of arts organizing and to share resources, knowledge and methods for artist-led, artist-run, and artist-centered projects, spaces and practices. The convening will take place at the Japanese American Cultural and Community Center from November 2 – 5, 2017.

## C. WeHo Arts: The Plan Data Visualization Concepts

The Commission received presentations from artists Maria del Carmen Lamadrid Zamora, Sean Noyce and YoMeryl and data visualization concepts for *WeHo Arts: The Plan*. The projects have been commissioned to increase the visibility of *WeHo Arts: The Plan* and continue to demonstrate the Commission's commitment to including artists in the planning process.

Maria del Carmen Lamadrid Zamora conceptualized *ArtEverywhere*, a one-day balloon mapping project with local teens to document potential sites for public art on the eastside. Using a 5.5-foot weather balloon with a camera attached to it the artist will take aerial photographs of the eastside. Lamadrid will overlay data from The Plan onto the photographs which will be shared via the City's website, social media platforms and/or printed materials.

Sean Noyce conceptualized *The Sky's the Limit*, an infographic campaign with a multifaceted installation. The data represented in the project as "word clouds" is based on the responses received in the opened ended answers from *The Plan's* online and in-person surveys. Each bubble in the cloud is scaled proportionately to the number of times a survey respondent mentioned a particular word. The artwork will be printed on vinyl banners and installed along the fence line of Hart Park on Sunset Boulevard and the construction fence at West Hollywood Park. The artwork will also be shared on the City's website and social media platforms and/or printed materials. The final

component will take shape as a balloon sculpture installation of the word clouds (intended to last 24-48 hours) and will be installed on Sunset Boulevard and West Hollywood Park adjacent to the banner installations.

Artist Team YoMeryl, Sarah Zucker and Bronwyn Lundberg, conceptualized an animated digital mural titled *The City of Creative Delights*. The animation depicts a stylized version of West Hollywood as a microcosm of creative expression, experimentation, and engagement. Within the large-scale tableau, microcosms of individual characters engage in activities that convey the values of *The Plan*. The digital mural will be exhibited on the electronic billboard at 8410 Sunset Boulevard from November 1 – December 31, 2017. Smaller gifs, details of the artwork, will be shared through the City's website, social media platforms and/or printed materials.

## D. Art on the Outside Subcommittee Report

The Commission received a report from the Art on the Outside Subcommittee Chair Catherine Lee on its meeting held September 28, 2017. Commissioner Lee indicated the Subcommittee, as part of its Consent Calendar, recommended approval of the following items for ratification by the Commission including:

- C. Approval of the Commercial Business Mural Application for 8552 Melrose Avenue featuring a work by Jason Woodside as art and not creative signage.
- D. Approval of the Commercial Business Mural Application for 1259 N. La Brea Avenue featuring a work by BELIN (Miguel Angel Belinchon Bujes) as art and not creative signage.
   Motioned approval of Items A D by Commissioner Gantman, seconded by Commissioner Williamson and approved.

1. Approval of *One Another* by Maxwell Carraher for installation at Havenhurst Park noting artist will assume the cost of insurance and engineering and that staff still needs final approval from the City's Facilities and Field Services Division.

Motioned approval of by Commissioner Rackley, seconded by Commissioner Williamson and approved.

- Approval in concept of Kate Costello Mural Series for installation at proposed locations in Plummer Park and budget not to exceed \$2,750 noting staff still needs final approval from the City's Facilities and Field Services Division.
   Motioned approval of by Commissioner Williamson seconded by Commissioner Gantman and approved.
- 3. Approval of *Another Kind of Growth* for installation in Kings Road Park and budget not to exceed \$3,000 (\$2,000 for artist and \$1,000 for landscaping). Motioned approval of by Commissioner Moreno-Freedman, seconded by Commissioner Williamson and approved.
- 4. Approval of artist MIGS (Miguel Andrisani) to work with staff to develop an original artwork, inspired by City Poet Kim Dower's poem *I Sing the Body West Hollywood*, for the banners in West Hollywood City Hall Community Plaza.

Motioned approval of by Commissioner Rackley, seconded by Commissioner Gantman and approved.

## E. Performing Arts and Cultural Affairs Subcommittee Report

The Commission received a report from the Performing Arts and Cultural Affairs Subcommittee on its meeting held September 14, 2017.

Commissioner Rackley reported the Subcommittee:

- Reviewed the application seeking musicians for Winter and Summer Sounds 2018-19 and concurred with staff's recommendation to continue programming Winter and Summer Sounds at 5 p.m., and requested staff to schedule concert dates in accordance with the budget and programming logistics.
- Reviewed cultural plan priorities and recommendations and provided direction on the implementation of WeHo Arts. It was the consensus of the Subcommittee to recommend that the Arts and Cultural Affairs Commission receive presentations from City departments and divisions to help guide the implementation process as well as assist the Commission with prioritizing its implementation strategies. The Subcommittee suggested that staff agendize a study session focused on City facilities and artists housing with Facilities and Field Services Manager Steve Campbell, Rent Stabilization and Housing Manager Peter Noonan, Assistant Director of Community Development John Keho, and Long Range and Mobility Planning Manger Bianca Siegl for the October 26, 2017 meeting.
- Received updates on Performing Arts and Cultural Affairs projects under the Subcommittee's oversight:

Coast Playhouse	The agreement with the production company currently in the space has been extended. The company will oversee community use on off nights.
Free Theatre in the Parks	Rogue Artist Ensemble received positive feedback from the community on its workshop production of Señor Plummer's Final Fiesta.
Hatch Digital Media Incubator Program	This grant opportunity is closed.
Laurel House Project	West Hollywood Councilmembers John Duran and Lauren Meister will lead a committee to discuss the Laurel House Project, and the Arts Division will be engaged in the discussion.
Library Programming	Staff announced three (3) upcoming WeHo Reads events: the 6 <sup>th</sup> Anniversary of the Library on October 6, Armistead Maupin on October 10 and Chris Kraus on November 14. ## F. Urban Art Subcommittee Report

The Commission received a report from the Urban Art Subcommittee on its meeting held September 21, 2017 and considered ratifying recommendations proposed by the Subcommittee.

Commissioner Gantman reported that the Subcommittee received a Stage II Schematic Plan presentation from art consultant Tiffany Lendrum on concept designs by artist team Cao Perrot in collaboration with Swarovski for Pendry Hotel and Condominium project at 8432 Sunset Boulevard. As a result, the Subcommittee expressed interest in Cao Perrot concept inspired by the Mangrove tree.

The tree rising approximately 22 feet high from a water mirror with a spread of 16 feet is comprised of blackened metal roots, trunk branches including a curtain of hanging branches embellish with 150,000 iridescent golden mother-of-pearl leaves

and 100,000 Swarovski crystals. Although the Subcommittee articulated concerns regarding the maintenance, theft and general care, Ms. Lendrum commented that the installation of a similar project in Texas was tested extensively and has withstood the elements including hurricanes.

#### **ACTIONS:**

- 1. Approval of Stage II Schematic Plan of Option 2 by artist team Cao Perrot in collaboration with Swarovski for the urban art project at 8432 Sunset Boulevard, in accordance with the City's Urban Art Policy and Guidelines.
- 2. Receive and file submissions from the developer in accordance with the Urban Art Policy and Guidelines including 1) schematic designs/drawings; site plans and elevations; a narrative description of the proposed art project including how it fits into the environment of the City; and proposed materials and color scheme; 2) implementation timeline; 3) outline of the art budget; 4) maintenance issues and 5) a signed copy of the developer/artist agreement.

Motioned approval of by Commissioner Rackley, seconded by Commissioner Moreno-Freedman and approved.

Commissioner Gantman then reported that the Subcommittee received a Stage I Artist Approval presentation from art consultant Dorka Keehn on proposed artists Bill Fitzgibbons; Camille Utterback; Erwin Redl; Jim Campbell; Ned Kahn and Refik Anadol for the mixed-use commercial development at 8497 Sunset Boulevard. The Subcommittee expressed a desire to diversify the urban art collection, noting preference for artists who are not currently in the collection. After a review of the artists presented, the Subcommittee expressed interest in Bill Fitzgibbons, Camille Utterback and Reifik Anadol.

#### **ACTIONS**:

- 1. Approval of of Stage I Artist Approval for artists Bill Fitzgibbons, Camille Utterback and Reifik Anadol for the urban art project at 8497 Sunset Boulevard, in accordance with the City's Urban Art Policy and Guidelines.
- 2. Receive and file submissions from the developer in accordance with the Urban Art Policy and Guidelines including: 1) The artist selection procedure used and 2) Artist(s) resume(s), biographical materials and evidence of artistic/cultural experience.

Motioned approval of by Commissioner Rackley, seconded by Commissioner Moreno-Freedman and approved.
