7. <u>UNFINISHED BUSINESS</u>

A. Urban Forest Management Plan

SUBJECT: The Public Facilities Commission received a presentation on the Heritage Tree Program for the City of West Hollywood from staff.

PUBLIC COMMENT: None.

The commissioners asked for clarification on the difference between a Protected Heritage Tree and a Heritage tree. They requested that the plaques outlined in policy be but on the designated trees. They asked how many Protected Heritage Trees are there in the City. They expressed concerns about the requirements to register Protected Heritage Trees on the property deed with County of Los Angeles. They also discussed a concern regarding impact of Protected Trees growing onto adjoining and neighbors trimming them. Commission Millan wanted to make sure the Heritage Tree Program will be in line with the Vision 2050 Strategic Plan.

ACTION: Refer the Heritage Tree Program to the Standing Heritage Committee for review and recommendations to the Commission. At a date yet to be determined, the Heritage Tree Program will return to the Commission for recommendation to the City Council to include the City's Heritage Tree Program as part of the Urban Forest Management Plan, when adopted by the City Council.

They suggested additional information on the signage such as contact information as well as additional language regarding spay and neutering. They expressed concern with the entrance and the fence being in close proximity to the basketball courts.

ACTION: Recommended to eliminate the first paragraph on the Etiquette sign; Include contact information on signs; Increase font size on main topic items; Consult with City Attorney regarding spayed and neutered dog warning.

Commissioner spoke about the difficulty of parking when visiting the Werle Building.

Commissioner Millan shared that he will not be present at the next Public Facilities Commission meeting as he will be on sabbatical.

Commissioner Sunnanon reiterated his concern with the location of the dog park entrance and fence being in close proximity with the basketball courts at the West Hollywood Park. He also requested a Tree Trimming schedule from staff. He asked Chair Rodriguez for clarification on the correct process when commissioners request to speak during a meeting.

Commissioner Dolan made staff aware of two trees that are dead trees in the city. He also expressed he was happy that the name Werle was preserved after the renovation of the building.

Chair Rodriguez expressed concern about the incident with public speaker that occurred in the beginning of the meeting. He requested that there be a security present during Public Facilities Commission meetings.
