#### THE OPPORTUNITY

#### **IDEAL CANDIDATE**

The ideal candidate will have current or recent hands-on recreation supervisory experience. A demonstrated track record creating and monitoring multiple program budgets; supervising and leading recreation special events and; supervising, developing and training staff is essential for success in this position. This position will interact with the public and all levels of staff, including executive-level staff and City Council, therefore, excellent interpersonal skills and experience in preparing staff reports is required.
