THE APPLICANT FAILS TO DISPLAY AND/OR PRESENT THIS PERMIT ON DEMAND TO ANY CITY INSPECTOR, CODE COMPLIANCE OFFICER, OR LAW ENFORCEMENT OFFICER ON DEMAND DURING CONSTRUCTION ACTIVITIES.

THE APPLICANT FAILS TO MITIGATE VALID NOISE COMPLAINTS TO THE SATISFACTION OF THE INVESTIGATING CITY INSPECTOR, CODE COMPLIANCE OFFICER, OR LAW ENFORCEMENT OFFICER.

ANY INVESTIGATING CITY INSPECTOR, CODE COMPLIANCE OFFICER, OR LAW ENFORCEMENT OFFICER OBSERVES AND DETERMINES THAT A CONDITION EXISTS WHICH POSES AN INJURIOUS CONDITION TO THE PUBLIC'S PEACE, HEALTH, SAFETY, OR GENERAL WELFARE.
