CALL TO ORDER: Mayor Heilman called the meeting to order at 6:10 p.m.

Mayor Heilman indicated that he would be out of the country and directed the City Clerk to bring an Item to the next meeting to discuss the first meeting in August.

Mayor Heilman requested that the meeting be adjourned in memory of those who lost their lives in the Santa Fe High School shooting.

Eddie Money administered the oath of office to the newly elected Mayor John J. Duran.

City Clerk Yvonne Quarker administered the oath of office to the newly elected Mayor Pro Tempore John D'Amico.

PRESENTATION TO OUTGOING MAYOR JOHN HEILMAN:

Incoming Mayor Pro Tempore D'Amico presented a plaque to outgoing Mayor Heilman for his year of service as Mayor. Outgoing Mayor Heilman thanked everyone for their hard work this past year.

Incoming Mayor Duran thanked the Communications staff for their hard work in organizing the Installation. He thanked Eddie Money for swearing him in. He discussed the work that the City has completed over the last year and is currently working on. He spoke about the history of the Sunset Strip. He introduced the new "Resist" yard signs with artwork by Shepherd Ferry

Mayor Pro Tempore D'Amico thanked his husband, Keith, for his support. He mentioned that he met with the Vice Mayor of Rome, Italy on a recent trip. Finally, he thanked everyone and indicated that he looks forward to working with the Council in the upcoming year.

COUNCILMEMBER COMMENTS AND MEETING ATTENDANCE REPORTS:

Councilmember Meister thanked outgoing Mayor Heilman for his year of service as Mayor. She congratulated incoming Mayor Duran and Mayor Pro Tempore D'Amico. She indicated that she looks forward to working on revitalizing the Sunset Strip. She reported that she attended the Beverly Hills Public Works Commission meeting. She reported that she represented the City at the Westside Cities Council of Governments (WSCCOG) and was appointed to the Southern California Council of Governments (SCAG) Community, Economic, and Human Development Committee. She spoke regarding Item 5.E. and requested that the Council receive the agenda packet for the July 9th meeting on June 29th. Both City Manager Arevalo and City Clerk Quarker

responded that they would review the Agenda Preparation Schedule and report back to Council. Lastly, she requested that the City Manager clarify that there are no changes to the development agreement in Item 4.A. City Manager Arevalo indicated that there are no changes to the Development Agreement with the Pacific Design Center relative to Item 4.A.

Councilmember Horvath congratulated Mayor Duran and Mayor Pro Tempore D'Amico. She thanked Councilmember Heilman for his service as Mayor. She inquired about the additional street cleaning in the City as it relates to Items 5.A, 5.B., 5.C., and 5.D. She commented that she would provide her contact with cannabis businesses at the next City Council meeting. She reported that she attended the Clean Power Alliance meeting. She attended the recent WSCCOG meeting and spoke regarding Metrorelated issues. She stated that she attended the California Contract Cities conference. She congratulated Councilmember Meister on her year as Chair of the WSCCOG. Finally, she congratulated incoming Board President of Christopher Street West (LA Pride) Estevan Montemayor. Mr. Montemayor reported on the new leadership in the organization. He commented that they plan to conduct a listening tour. He also provided information about the upcoming LA Pride event and possible subsidies for tickets.

Councilmember Heilman thanked everyone for their hard work with the Russian Cultural Festival, especially Tatiana Rodzinek. He indicated that he would like further discussion with the Sunset Strip Advisory Board about the Sunset Strip and specifically, plans for the upcoming year.

Mayor Pro Tempore D'Amico indicated that when the City Council discusses the Visit West Hollywood item at the next meeting, he would like to hear about what they are doing to attract LGBT travelers. He mentioned the Transgender community and the City's additional funding of \$15,000 for additional programming during LA Pride.

Mayor Duran indicated that he would like to discuss holiday décor along Sunset and updating the holiday décor along Santa Monica Blvd.

CITY MANAGER'S REPORT:

City Manager Arevalo mentioned that staff is utilizing the Poinsettia Homeless Collaborative to mitigate the impacts of the homeless encampment. He commented that the gas main from Sunset to Sherbourne is being replaced beginning today. He commented that the Facilities division is conducting alley work from Gardner to Genesee. He noted that the Helen Albert Farmers Market will be closed on Monday, May 28th in observance of the Memorial Day holiday. He responded to City Council questions regarding the City's Business Improvement Districts (Sunset and Santa Monica) and commented that staff will address those questions during the Public Hearings on June 4th. Finally, he mentioned that Christopher Street West (CSW) is allocating money for Transgender events including the moonlight program and \$10,000 to help subsidize free tickets for members of the Transgender community.

FISCAL IMPACT ON CONSENT CALENDAR:

City Clerk Quarker stated that the fiscal impact on the Consent Calendar is \$224,800 in expenditures, \$0 in potential revenue, and (\$0) in waived fees.
