The Paycheck Fairness Act i will deter wage discrimination by closing loopholes in the law, and will bar retaliation against workers who disclose their wages. The bill also allows women to receive the same remedies in court for pay discrimination as those subjected to discrimination based on race or national origin. The House passed this bill in January but the Senate has yet to pass it.
