# V. A. Legislative & Policy Issues Subcommittee Report

(5 - 10 min)

The Board will review information regarding various federal and state bills that address the Women's Advisory Board's stated legislative priorities of women's health, violence against women and pay equity.

#### Women's Health

- H.R. 1211 (Sandlin), Women Veteran's Healthcare Improvement Act, a bill to expand and improve VA health care services for women veterans.
- H.R. 2583 (Boswell), Women Veterans Access to Care, a bill to direct the Secretary of Veterans Affairs to improve health care for women veterans, and for other purposes
- S.634 /H.R.1585, Fitness Integrated with Teaching Kids Act (FIT Kids Act)

A bill to amend the Elementary and Secondary Education Act to enhance children's health

# **Violence Against Women**

- AB 688 (Eng) Requires law enforcement to hold an alleged domestic violence perpetrator until they can brought before a judge.
- SB 197 (Pavley) Establishes a procedure for domestic violence victims to take part in conditional examinations (videotaped testimony) if the life of the victim is in jeopardy.
- AB 789 (De Leon) Authorizes a court to issue a search warrant to law enforcement in domestic violence cases to seize firearms when an offender has a domestic violence protective order against them.

- AB 532 (Lieu) Authorizes a search warrant when property to be seized includes a firearm or deadly weapon possessed by someone detained on a mental emergency or at the scene of a domestic violence incident.
- AB 383 (Lieu) would extend the limitation on the time period for analyzing biological evidence (DNA kits) from 2 years to 5 years.

# **Equity/Equal Rights**

• High School Information Collection Act (S. 471) and the High School Athletics Accountability Act (H.R. 2882) These bills would make participation rates and expenditures for high school athletes available to the public, helping communities better enforce Title IX.

**Recommendation:** Receive and File. Consider taking action in support.
