A. Pending State Legislation With Previous Recommendations from WAB

The Board will receive updates regarding the status of pending state legislation that the Board has previously made recommendations about.

- 1. State Legislation Regarding Sexual Harassment:
 - AB 1870, SB 1038, SB 224 clarifies that sexual harassment by investors, elected officials, lobbyists, directors and producers are prohibited.
 - SB 1300 includes several important reforms to protect workers' rights and combat sexual harassment.
- 2. State Legislation Regarding Women's Health:
 - SB 320 would express findings and declarations of the Legislature relating to the availability of abortion by medication techniques at on-campus student health centers at public postsecondary educational institutions in the state.
 - SB 937, AB 1976, AB 2785 regarding lactation accommodations in the workplace and schools and AB 2507 - regarding breastfeeding support in jails.

RECOMMENDATION: Review and Discuss.

B. Pending State Legislation Tracked by WAB

The Board will receive updates about the status of pending State legislation that the Board is tracking.

1. SB 826 – would require that all California-based public companies add at least one female board member to their boards by the end of 2019.

RECOMMENDATION: Review and Discuss. Consider additional advocacy opportunities.

C. Federal Legislation & Policy

The Board will receive updates about the status of Federal legislation and policy that the Board is tracking.

- 1. Bills Regarding Immigration Policy:
 - Family Unity Rights and Protection Act, H.R. 6236, which would require the federal government to reunite families that have been forcibly separated at the border.
 - Keep Families Together Act, S.3036, promotes family unity by prohibiting Department of Homeland Security (DHS) officials from separating children from their parents, except in extraordinary circumstances
 - Help Separated Children Act, H.R. 5950, which would protect children affected by immigration enforcement actions.
 - 2. Update regarding federal order for reunification of immigrant minors separated from their parents at the U.S. boarder under the zero tolerance immigration policy.

RECOMMENDATION: Review and discuss. Consider additional advocacy opportunities.

D. Additional Legislative and Advocacy Updates:

- 2. Title X Status Update For more than 40 years, the Title X (ten) family planning program has served as the nation's only dedicated source of federal funding for family planning. Annually funded by Congress through the discretionary appropriations process, the Title X program supports high-quality, culturally sensitive family planning services and other preventive health care for low-income, under-insured and uninsured individuals who may otherwise lack access to health care.
- Title IX Status Update- Title IX is a comprehensive federal law that prohibits discrimination on the basis of sex in any federally funded education program or activity.
