- REQUEST:** Applicant is requesting to demolish eight existing dwelling units on four adjacent parcels in order to construct a new, four-story, 22-unit condominium building, including four affordable dwelling units over two levels of subterranean parking. The proposed project utilizes three affordable housing concessions.
