Member Fairchild spoke about doing pro bono work for the Transgender Community during the month of August

Member Wen spoke of attending the City Council meeting concerning President Donald Trump. He spoke at the meeting concerning the military. He spoke of being mis-gendered by a member of the audience at City Council. Member Wen spoke of attending the National Night Out events and meeting the producers of "I love Nicole" video. Member Wen spoke of staff member from LAUSD meeting with staff about using Plummer Park for a conference. He spoke of attending Southern Leadership Council and asking for a special day for the Transgender Community. Member Wen also gave an update on a Russian Transgender Community member who he has spoken about in the past. Member Wen spoke highly of a Russian restaurant in the city. Member Wen attended the Coffee with the Copps event at McDonalds. He also spoke of serving on the National Host Community for Bi-medical Conference on AIDS.

Member Samala spoke of the next Midnight Stroll being on September 21-22. Member Samala is still working on having the Midnight Stroll come through West Hollywood. Member Samala spoke of attending Women's Equality Day.

Member Deaton spoke of speaking with a member of Women's Advisory Board concerning the Women's Visibility Day. Member Deaton spoke of wanting a closer relationship with the WAB.

Member Juarez spoke concerning the Midnight Stroll. She spoke of Grindr highlighting a story on the Midnight Stroll.

8. NEW BUSINESS

8A. **Subject:** John Erickson, Hollywood NOW: 2019 Vagina Monologues Co-Sponsorship from the board

between the Transgender Community and business establishments.

Member Wen spoke of 3 incidents since being on the board. He spoke of having Trans Cultural Training. Member Wen spoke of a recent incident and shared that he had met with the victims of the alleged incident.

Member Samala spoke of the same incident and what she was told had happened.

Members Juarez and Deaton requested staff to look into having a required Cultural Diversity Certification Training for all businesses in the City.

Member Johnson cautioned the board that the City cannot penalize or force a business to take training.

Staff informed the board that 3 trainings were coming up in the next few months. Staff also informed the board that she would look into a training and certification program.

Member Johnson spoke of feeling very behind on the November events and stressed that the reason for the success last year was the community involvement in the event.

Member Wen volunteered to reach out to Gina Bingham at the LA Gay and Lesbian Center to start working on the name project for TDOR.

Board Members asked that alters be considered once again at TDOR.
