Deadline for proposal submission electronically. Any proposal received after this deadline will be considered to be non-responsive.

### **Scope of Work:**

The City of West Hollywood is seeking proposals from qualified surveying consultants, licensed in the State of California, for preparation of 500-foot radius maps around properties where elected and appointed decision-makers live. The radius maps shall show the individual's property and all surrounding properties within the 500-foot radius measurement, as well as nearby properties. The radius map shall show all property lines of the parcels, as well as, their identification and address. The radius map shall show the street names within the area. The 500-foot measurements shall be measured from the property line extents of the parcel where the individual lives. Any property within the radius, or any property that the radius line crosses, shall be identified differently from the adjacent properties. A tabulation in excel format of all such parcels and their addresses shall also be created. The radius maps shall be the product of professional surveying and shall be stamped by a California licensed surveyor indicating their accuracy.
