# **ADDENDUM #1**

All changes, additions and/or clarifications detailed in this Addendum, and previously issued Addenda, are hereby incorporated into the Bidding Documents for the above-stated project, and modify the original document. Bidder shall acknowledge receipt of Addendum prior to bid submission.

This Addendum is issued prior to the bid opening date to inform bidders of revisions to the Bidding Documents, which may or may not contain changes that are materially substantial to the Bid, and all is hereby made a part of the Contract Documents. In case of a conflict between Bidding Documents and this Addendum, this Addendum shall govern. All requirements contained in the Contract Documents shall apply to this Addendum, and the general character of the work called for in this Addendum shall be the same as originally set forth in the applicable portions of the Contract Documents for similar work, unless otherwise specified under this Addendum, and all incidental work necessitated by this Addendum as required to complete the work shall be included in the bid, even though not specifically mentioned in this Addendum. The balance of the contract documents shall remain unchanged.

This Addendum shall take precedence over all other conditions, specifications and requirements as stated in the Notice Inviting Bids and Bidding Documents. Except as noted in this Addendum, and previously issued Addenda, all other provisions of the Notice Inviting Bids and Bidding Documents shall remain.

PUBLIC NOTICE IS HEREBY GIVEN that the City of West Hollywood as AGENCY, invites Sealed Bids for the above stated services from <u>Contractors</u> which shall be received only by submitting electronically at <a href="https://www.weho.org/city-government/city-departments/public-works/bids">https://www.weho.org/city-government/city-departments/public-works/bids</a> for the above stated work and will only receive such bids no later than the hour of **10:00 AM on December 17, 2018.** 

The work to be done consists of furnishing all materials, equipment, tools, labor, and incidentals as required to perform demolition of existing AC equipment, Installation of new AC equipment, Electrical work for AC equipment, Flashing & Sheet Metal, Exterior Cement Plaster, Painting, Roof Patching, Installation of new building DDC controls system and integration of AC equipment with new DDC controls, New zone wall temperature sensors with display and user interface for new AC equipment.

Proposals shall be submitted electronically. Copies of the Request for Proposals and associated documents are available for free from the City of West Hollywood website <a href="https://www.weho.org/city-government/city-departments/public-works/bids">https://www.weho.org/city-government/city-departments/public-works/bids</a>.

<u>Please note the terms Project and Work are interchangeable as is Proposals/Proposer</u> and Bid/Bidder.

A contractor or subcontractor shall not be qualified to bid on, be listed in a bid proposal, subject to the requirements of Section 4104 of the Public Contract Code, or engage in the performance of any contract for public work, as defined in this chapter, unless currently registered and qualified to perform public work pursuant to Section 1725.5 of the Labor Code. It is not a violation of this section for an unregistered contractor to submit a bid that is authorized by Section 7029.1 of the Business and Professions Code or by Section 10164 or 20103.5 of the Public Contract Code, provided the contractor is registered to perform public work pursuant to Section 1725.5 of the Labor Code at the time the contract is awarded.

Any contract entered into pursuant to this notice will incorporate the provisions of the California State Labor Code. Pursuant to the provisions of Section 1773.2 of the Labor Code, the minimum prevailing rate of per diem wages for each craft, classification, or type of workman needed to execute the contract shall be those determined by the Director of Industrial Relations of the State of California, which are on file at the City Hall, City of West Hollywood, 8300 Santa Monica Boulevard, West Hollywood, California 90069, and are available to any interested party on request.

The City of West Hollywood's <u>Living Wage Ordinance</u> shall be followed when applicable. West Hollywood Municipal Code: Chapter 3.20 Living Wage Requirements for Service Contracts.

Attention is directed to the provisions of Section 1777.5 (Chapter 1411, Statutes of 1968) and 1777.5 of the Labor Code concerning the employment of apprentices by the Contractor or any such subcontractor under him. Affirmative action to ensure against discrimination in employment practices on the basis of race, color, national origin, ancestry, sex, religion, sexual orientation, or handicap will also be required.

The AGENCY hereby affirmatively ensures that minority business enterprises will be afforded full opportunity to submit bids in response to this notice and will not be discriminated against on the basis of race, color, national origin, ancestry, sex, or religion in any consideration leading to the award of contract.

In entering into a public works contract, or a subcontract, to supply goods, services, or materials pursuant to a public works contract, the Contractor, or subcontractor, offers and agrees to assign to the awarding body all rights, title, and interest in, and to, all causes of action it may have under Section 4 of the Clayton Act (15 U.S.C. Section 15) or under the Cartwright Act (Chapter 2 [commencing with Section 16700] of Part 2 of Division 7 of the Business and Professions Code), arising from purchases of goods, services, or materials pursuant to the public works contract or the subcontract. This assignment shall be made and become effective at the time the awarding body tenders final payment to the Contractor, without further acknowledgement by the parties.

No contractor or subcontractor may be listed on a bid proposal for a public works project (submitted on or after March 1, 2015) unless registered with the Department of Industrial Relations pursuant to Labor Code section 1725.5 [with limited exceptions from this requirement for bid purposes only under Labor Code section 1771.1(a)].

This project is subject to compliance monitoring and enforcement by the Department of Industrial Relations.

**Interest in More Than One Submission:** No contractor shall be allowed to make, submit or be interested in more than one Statement of Qualification. However, a person, firm, corporation or other entity that has submitted a sub proposal to a contractor, or that has quoted prices of materials to a bidder, is not thereby disqualified from submitting a sub proposal or quoting prices to other bidders submitting a bid to the Owner.

**Mandatory Pre-Proposal Meeting:** The City will host a Mandatory Pre-Bid Meeting on December 5 at 8:00 AM at Plummer Park Community Center; 7317 Santa Monica Blvd., West Hollywood, CA 90046. Please submit your RSVP through the electronic process if you plan to attend. Should the City not receive any RSVP's, the meeting will not be held.

Requests for Clarification (RFI's) and Questions: All questions and requests for

information shall be submitted electronically at <a href="https://www.weho.org/city-government/city-departments/public-works/bids">https://www.weho.org/city-government/city-departments/public-works/bids</a> under the above stated project. Any questions addressing the interpretation or clarification of the Bid Forms or the Bid Documents <a href="must">must</a> be submitted no later than 10:00 A.M. December 7, 2018 through the City's electronic submission process. Following this deadline no questions regarding the statement of qualifications packet will be accepted.

Bid Security and Insurance Certificates; Performance and Payment Bonds: All Proposals shall must be accompanied by certified or cashier's check to be submitted to the City Clerk prior to deadline for submission of proposals (proposals will only be accepted through the online process), or bidder's bond, made payable to the AGENCY for an amount no less than ten percent (10%) of the total bid price, this can be scanned and submitted as part of the proposal. Any bid not accompanied by such a guarantee will not be considered.

The successful proposer will be required to furnish, within five business days of the written Notice of Award, insurance certificates and endorsements as described in the Bid Documents, a Performance Bond in the amount of one hundred percent (100%) of the Total Bid Price, and a Payment (Material and Labor) Bond in the amount of one hundred percent (100%) of the Total Bid Price, on the forms provided and in the manner described in the Bid Documents. Only bonds executed by an admitted surety insurer, as defined in Code of Civil Procedure Section 995.120, shall be accepted. The surety must be a California-admitted surety with a current A.M. Best's rating no less than A:VII and satisfactory to the City. If a California-admitted surety insurer issuing bonds does not meet these requirements, the insurer will be considered qualified if it is in conformance with Section 995.660 of the California Code of Civil Procedure, and proof of such is provided to the City.

Add Alternate(s): Add alternates will be awarded in the order they are listed in the bid documents.

**Lowest Bidder:** The lowest bid shall be the lowest bid price on the base contract without consideration of the prices on the additive or deductive items.

**Bid Protests:** Shall follow the City of West Hollywood's <u>Bid Protest Procedure</u> as found in the Municipal Code: Chapter 3.08 Purchasing System; Section 3.08.036 Bid Protest Procedure Applicable to Public Works Construction Projects.

License Requirements: Pursuant to Section 7028.15 of the Business and Professions Code and Section 3300 of the Public Contract Code, all bidders must possess proper licenses for performance of this Contract. Contractors shall possess at a minimum the following valid California Contractor license in order to perform the Work: C-20 Warm-Air Heating, Ventilating and Air-Conditioning Contractor. All Subcontractors must possess the appropriate licenses for each trade subcontracted and they shall be listed on the bid documents as requested to include percentage and dollar value of work.

Standard Specifications: The Standard Specifications of the Agency are contained in the most recent edition of the STANDARD SPECIFICATIONS FOR PUBLIC WORKS CONSTRUCTION, including the all supplements, as written and promulgated by the Joint Cooperative Committee of the Southern California Chapter of the American Public Works Association and the Southern California District of the Associated General Contractors of California. The Standard Specifications set forth above will control the General Provisions for this Contract except as amended in the bid documents by the Plans, General Conditions, Special Provisions, Technical Provisions, or other Contract Documents.

**Owner's Rights:** The City of West Hollywood reserves the right to reject any and all proposals or statement of qualifications or to waive any irregularities or informalities in any statement of qualifications or in the proposals should it deem this necessary for the public good, and also the bid of any Proposer who has been delinquent or unfaithful in any former contract with the City of West Hollywood and to take all statement of qualifications under advisement for a period of ninety (90) days. No Proposer may withdraw its submission for a period of ninety (90) days after the date from the opening thereof.

THIS IS A PUBLIC WORKS PROJECT REQUIRING PREVAILING WAGE. ADDITIONALLY, THE CITY OF WEST HOLLYWOOD'S LIVING WAGE ORDINANCE APPLIES TO THIS AGREEMENT - IT IS THE SOLE RESPONSIBILITY OF THE CONTRACTOR TO PAY STAFF ACCORDINGLY.

Bids must be submitted electronically through the City Electronic Bidding System.

The quantities listed below are for comparison and price establishment only this agreement does not provide for any guaranteed compensation and compensation will be solely based on work quantities completed to the satisfaction of the City. **Mark-Up** shall include trade related tools, trade related equipment (transportation, relevant expenses, overhead, taxes and profit, to perform work, which may be involved in the contract (mark-up **does not** include materials or equipment rentals unless specified elsewhere in these documents).

1. BASE BID SCHEDULE SHALL BE <u>84 CALENDAR DAYS</u> FOR COMPLETION OF WORK (AND SHALL INCLUDE AN ADDITIONAL NON-COMPENSABLE 30 CALENDAR DAYS FOR COMPLETION OF PUNCH LIST ITEMS)

Base bid shall be calculated using straight-time. Overtime compensation will not apply except as required by the Department of Industrial Relations trade classifications.

Unit prices shall include all labor, material, tools, equipment, traffic and warning devices, transportation, overhead and profit to perform the work. All work shall be priced at prevailing wage rates if applicable and/or the City of West Hollywood Living Wage.

Per the Project Manual, Contract Documents, Specifications and Standard Drawings the City is requesting bid pricing for a regular schedule in which the Contractor shall complete all the required work in every detail within **84 CALENDAR DAYS** after date of Notice to Proceed, exclusive of verified equipment and/or materials lead time and any required maintenance period. (All items must be filled out completely).

In accordance with the Project Manual Specifications, the Contractor shall provide a third party accredited and licensed security guard for the entire duration the Contractor, and/or those acting on the behalf of the Contractor, are onsite. Cost for said security guard shall be included in the cost of the bid.
